**ORDINANCE NO. 1845**

**AN ORDINANCE APPROVING A SPECIAL USE FOR A CAR WASH IN THE B-3 RETAIL AND SERVICE BUSINESS DISTRICT ON CERTAIN LANDS LOCATED IN THE CITY OF ANDOVER, KANSAS, UNDER THE AUTHORITY GRANTED BY THE ZONING REGULATIONS OF THE CITY.**

WHEREAS, the governing body of the City of Andover, Kansas (the "City") has received a recommendation from the Andover City Planning Commission on Case No. Z-SU22-0002; and

WHEREAS, the Governing Body finds proper notice was given and a public hearing was held on Case No. Z-SU22-0002 on September 20, 2022, all as provided by law and under authority and subject to the provisions of the Zoning Regulations of the City.

**NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:**

Section 1. The recommendation of the Planning Commission is hereby approved and the special use is approved to allow a car wash on the property described below, zoned as B-3 Retail and Service Business District.

Legal description:

Block 1, Lots 5-7, Marketplace Commercial Second Addition

Parcel 1:

Lot 5, EXCEPT beginning at the northwest corner of said Lot 5; THENCE East 100.00 feet; THENCE South 52.39 feet; THENCE West 100.00 feet; THENCE North 52.58 feet, to the Point of Beginning; EXCEPT the West 35.00 feet therefrom.

Parcel 2:

Lot 6, EXCEPT beginning at the northwest corner of said Lot 6; THENCE East 104.1 feet; THENCE South 50.34 feet; THENCE West 104.1 feet; THENCE North 52.39 feet, to the Point of Beginning.

Parcel 3:

Lot 7, EXCEPT beginning at the northwest corner of said Lot 7; THENCE East 199.43 feet; THENCE South 49.97 feet; THENCE West 199.4 feet; THENCE North 50.34 feet, to the point of Beginning.

General location:

Northwest Corner of E. Cloud Avenue and S. Plaza Street, Andover, Butler County, Kansas

Conditions:


- 1) That the applicant utilize a professional traffic operations engineer to produce a study detailing the traffic impact of the development at the proposed location.


