**5.1 SP-A23-0004 – REVIEW OF THE SITE PLAN FOR THE 13TH STREET SPORTS PARK
GENERALLY LOCATED NORTH OF E. 13TH STREET AND WEST OF N. PRAIRIE
CREEK ROAD, ANDOVER, KANSAS**

Mr. Mangus stated that the City is proposing a 13th Street Sports Park master plan that includes new baseball/softball fields, a pickleball court, wet and dry play areas, and a destination playground. Mr. Mangus stated that the 13th Street Sports Park master plan was developed from efforts stemming from the Parks & Recreation Playbook 2030, a 10-year citywide parks master plan approved by the City Council in July 2021. Mr. Mangus stated that the plan for the park includes signage, landscaping, parking, building elevations, colors, materials, and site lighting.

Homer Henry made a motion to approve the site plan for the 13th Street Sports Park. Motion seconded by Matt Linke. Motion carried 5/0.

**5.2 SP-A23-0005 – REVIEW OF THE SITE PLAN FOR THE PROPOSED RESTROOM
ALONG THE REDBUD TRAIL GENERALLY LOCATED AT THE NORTHWEST CORNER
OF N. MAIN STREET & W. HARRISON STREET, ANDOVER, KANSAS**

Mr. Mangus stated that the City is proposing a new restroom south of the Redbud Trail and just west of the existing shade pavilion. Mr. Lanzrath stated that the restroom will be constructed of brick and stone veneer to match the neighboring shade pavilion.
