5.1 ESTABLISH PRELIMINARY PUD (Z-PUD23-0003) – REVIEW OF AND RECOMMENDATION ON THE LAFAYETTE ADDITION PRELIMINARY PUD GENERALLY LOCATED AT THE NORTHWEST CORNER OF W. LAFAYETTE STREET AND N. CHURCH STREET, ANDOVER, KANSAS

Mr. Mangus introduced the agenda item and stated that the applicant desires to establish a preliminary planned unit development (PUD) overlay district, which is intended to allow the underlying zoning districts to be adapted for a specific development project. Mr. Mangus stated that the applicant intends to retain the SF-2 zoning district while modifying the general provisions to allow for more density.

Mr. Mangus stated that the staff had a few outstanding comments related to stormwater detention and quality improvements, as well as the addition of a Wichita water easement and adding the general provisions onto the PUD plan.

Kirk Miller of KE Miller Engineering, representing the applicant, stated that they would make the requested corrections.

Gary Israel made a motion to recommend that the Planning Commission approved the establishment of The Lafayette Addition Preliminary PUD Plan with the condition that stormwater quality improvements be made, a waater easement added, and the general provisions were added to the PUD plan. Marla Canfield seconded the motion. Motion carried 3/0.
