ORDINANCE NO. 1899

AN ORDINANCE ANNEXING A PORTION OF HARRY STREET TO THE CITY OF ANDOVER, KANSAS.

WHEREAS, Butler County, Kansas (the "County") is the owner of the portion of the Harry Street right-of-way described in Section 1 (the "Road"); and

WHEREAS, the City desires to have said Road annexed into the City limits pursuant to K.S.A. 12-520(a)(3); and

WHEREAS, the County, as owner of the Road right-of-way, has provided written request for and consent to the annexation, and therefore, pursuant to K.S.A. 12-520a(f), no resolution, notice or public hearing are required; and

WHEREAS, the governing body of the City finds it advisable to annex such Road.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, BUTLER COUNTY, STATE OF KANSAS:

Section 1. That the following described Road, located in Butler County, Kansas is hereby annexed and made a part of the City, to-wit:

All existing public road rights of way of Harry Street east of 159<sup>th</sup> St.(Butler/Sedgwick County Line) to Prairie Creek Road

Section 2. Pursuant to K.S.A. 12-522, upon passage and publication of this annexation ordinance (the "Ordinance"), the City Clerk shall file a certified copy of such Ordinance with the County Clerk, the Register of Deeds, and the County Election Commissioner, if any, of Butler County.

Section 3. This Ordinance shall take effect and be in full force from and after its adoption by the governing body of the City, approval by the Mayor and either (a) publication once in the official newspaper of the City, or (b) publication of a summary of this Ordinance certified as legally accurate and sufficient by the City Attorney.




