5.1 SP-A24-0006 — REVIEW AND APPROVAL OF THE SITE PLAN FOR BUTLER COMMUNITY COLLEGE, GENERALLY LOCATED AT 622 E. CLOUD AVENUE, ANDOVER, KANSAS

Mr. Westphall introduced the case, a modification of existing monument signs for Butler Community College Culinary along US-54. He explained that the two monument signs, one on the north side and one on the south side of the property, would be retained, but with additions per the given plans. Mr. Mangus added that this case was precipitated by the college in response to a change in branding standards, and that the monument signs that were erected did not fully meet the college's requirements at the time.

Homer Henry made a motion to approve the sign plan for Butler Community College Culinary at 622 E. Cloud Ave. Motion seconded by Todd Woolsoncroft. Motion carried 4/0.

5.2 SP-A24-0008 — REVIEW AND APPROVAL OF THE SITE PLAN FOR EQUITY BANK, GENERALLY LOCATED AT 345 N. ANDOVER ROAD, ANDOVER, KANSAS

The first applicant, Jay Schroeder with Hutton, explained the site plan modification: the bank will be removing its drive-thru window in favor of two ITMs. He added that the middle lane of the drive-thru area would be widened slightly, while the lane that previously allowed for window access would be narrowed to compensate. He stated that this lane would not be purely used to access the night drop for the bank. Mr. Schroeder also stated that Hutton had secured the same brick as is currently featured on the outside of the building, so the infill where the window used to be located will look natural and consistent.
