ORDINANCE NO. 1924

AN ORDINANCE INCORPORATING BY REFERENCE THE STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES (51st EDITION), AS PUBLISHED BY THE LEAGUE OF KANSAS MUNICIPALITIES IN 2024; AND AMENDING CHAPTER XVIII, ARTICLE 1, SECTION 18-101 AND SECTION 18-103 OF THE CODE OF THE CITY OF ANDOVER, KANSAS.

WHEREAS, pursuant to K.S.A. 12-3009 *et seq.*, and K.S.A. 12-3301 *et seq.*, all as amended, the City of Andover, Kansas (the “City”) desires to incorporate by reference the Standard Traffic Ordinance for Kansas Cities (51st Edition), as published by the League of Kansas Municipalities in 2024 (the “STO”), with certain deletions, modifications and additions, as previously or hereafter set forth in the Code of the City of Andover, Kansas (the “Code”); and

WHEREAS, the City desires to amend the Code to reflect incorporation of the latest STO; and

WHEREAS, the governing body of the City finds it advisable to incorporate the STO by reference and to amend the Code to reflect incorporation of the latest STO.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, BUTLER COUNTY, STATE OF KANSAS:

SECTION 1. This Ordinance incorporating the STO supersedes and repeals Ordinance No. 1882, but solely to the extent Ordinance No. 1882 incorporated the previous version of the STO, and any and all previous ordinances similar thereto or the incorporating previous editions thereof. Any remaining provisions of Ordinance No. 1882 shall remain in full force and effect.

SECTION 2. The City hereby incorporates by reference the Standard Traffic Ordinance for Kansas Cities (51st Edition), as published by the League of Kansas Municipalities in 2024, with the certain deletions and modifications as set forth in the Code. Accordingly, Section 18-101 of the Code is hereby amended to read, as follows:

18-101. Standard traffic ordinance incorporated.

Pursuant to the provisions of K.S.A. 12-3009 *et seq.*, and K.S.A. 12-3301 *et seq.*, the Standard Traffic Ordinance for Kansas Cities (51st Edition), as prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas in 2024 (the “STO”), is hereby adopted by reference, as if said model or standard ordinance were set out in full herein, save and accept such sections, parts, or portions as may be omitted or deleted, modified, or changed elsewhere within the Code of the City of Andover, Kansas.

SECTION 3. Section 18-103 of the Code is hereby amended to read, as follows:

18-103. Copies.

The City Clerk or Deputy City Clerk of Andover, Kansas shall prepare and make at least one (1) copy of said STO, by marking or stamping thereon "Official Copy as incorporated by Ordinance No. 1924" with all sections or portions intended to be omitted or changed clearly marked to show such omission, and to which shall be attached a copy of this Ordinance and filed with the City Clerk to be open for inspection and available to the public at all reasonable business hours.

SECTION 4. This Ordinance shall take effect and be in full force from and after its adoption by the governing body of the City, approval by the Mayor and published once in the official newspaper of the City.
