

RESOLUTION 24-44

A RESOLUTION DECLARING THE ENTIRE BOUNDARY OF THE CITY OF ANDOVER, KANSAS.

BE IT RESOLVED by the governing body of the City of Andover, Kansas:

That the entire boundary of the City of Andover, Kansas, is hereby declared to be, and is described as follows:

- ❖ **COMMENCING** at the Northwest corner of **Section 8**, Township 27 South, Range 3 East of the Sixth Principal Meridian, Butler County, Kansas;
- ❖ Thence Easterly along the North line of said Section 8, a distance of 993.09 feet to the **POINT OF BEGINNING**;
- 1. Thence Easterly along said North line of said Section 8, a distance of 304.2 feet to the Northeast corner of the Northwest Quarter of the Northwest Quarter of said Section 8;
- 2. Thence Southerly along the East line of said Northwest Quarter of the Northwest Quarter to the Northwest corner of the Southeast Quarter of the Northwest Quarter of said Section 8;
- 3. Thence Easterly along the North line of said Southeast Quarter of Northwest Quarter to the Northeast corner of said Southeast Quarter of the Northwest Quarter;
- 4. Thence Southerly along the East line of said Southeast Quarter of the Northwest Quarter to the Southeast corner of the Northwest Quarter of said Section 8, also commonly known as the Center of Section 8, Township 27 South, Range 3 East;
- 5. Thence Easterly along the North line of the Southeast Quarter of said Section 8, to the Northwest corner of Lot 3, Block A, Revised Plat of Easter's First Addition, Butler County, Kansas;
- 6. Thence Southerly along the West line of Lots 3, 2 and 1, said Block A, to the Southwest corner of Lot 1, said Block A;
- 7. Thence Southerly along the West line of the Northeast Quarter of the Southeast Quarter of said Section 8, to a point 329.23 feet North of the Southwest corner of said Northeast Quarter of the Southeast Quarter of said Section 8;
- 8. Thence Easterly, parallel with the South line of said Northeast Quarter of the Southeast Quarter of said Section 8, to a point 903 feet West of the East line of said Section 8;
- 9. Thence Northerly, parallel with the East line of said Section 8, to the South line of Lot 1B, Block D, said Revised Plat of Easter's First Addition;
- 10. Thence Easterly along the South lines of Lots 1B, 2, 3, 4 and 5, Block D, said Revised Plat of Easter's First Addition, to the Southeast corner of Lot 5, Block D, said Revised Plat of Easter's First Addition;
- 11. Thence Northerly along the East line of said Lot 5 a distance of 50 feet to the Westerly extension of the South line of Lot 1, Block E, said Revised Plat of Easter's First Addition;
- 12. Thence Easterly along said Westerly extension and along said South line of Lot 1 to the Southeast corner of said Lot 1, Block E, said Revised Plat of Easter's First Addition;
- 13. Thence Northerly along the East lines of Lots 1, 2 and 3, Block E, said Revised Plat of Easter's First Addition, to the Northeast corner of said Lot 3, Block E, being coincident with the Southeast corner of Lot 4, said Block E;
- 14. Thence Westerly along the South line of said Lot 4, Block E, a distance of 20 feet;
- 15. Thence Northerly, parallel with the East line of said Lot 4, Block E, to the North line of said Lot 4, Block E;
- 16. Thence Easterly to the Southeast corner of Lot 5, said Block E;
- 17. Thence Northerly along the East line of said Lot 5, Block E, to the Northeast corner of said Lot 5, Block E;
- 18. Thence Westerly along the North line of said Lot 5, Block E, to the Southwest corner of Lot 11, said Block E;
- 19. Thence Northerly along the West line of said Lot 11, Block E, to the Northwest corner of said Lot 11, Block E;
- 20. Thence Easterly along the North line of said Lot 11, Block E, and along the Easterly extension thereof, to the Northeast corner of the Southeast Quarter of **Section 8**, Township 27 South, Range 3 East, said Northeast corner

being coincident with the Southwest corner of the Northwest Quarter of **Section 9**, Township 27 South, Range 3 East;

21. Thence along the West line of said Northwest Quarter on a Kansas coordinate system of 1983 south zone bearing of North $00^{\circ}58'14''$ West, a distance of 315.55 feet to a point on the south line of the right of way for the Kansas Turnpike Authority (KTA);
22. Thence along said South line of the right of way for the Kansas Turnpike Authority for the next three consecutive courses, North $89^{\circ}01'46''$ East, a distance of 27.30 feet;

28. Thence along the extended South line of the right of way for the Kansas Turnpike Authority, North $58^{\circ}21'01''$ East, a distance of 908.44 feet to a point on the East line of said Northwest Quarter of Section 9;

63. Thence Westerly to the Northeast corner of Lakeview Heights, an Addition in Butler County, Kansas;

64. Thence Southerly along the East line of said Lakeview Heights, to a point on the North line of the right of way for Harry Street, said point being 30 feet North of the South line of said Section 29;
65. Thence Easterly along said North line of the right of way for Harry Street and 30 feet North of said South line of Section 29 to the East line of said Section 29, Township 27 South, Range 3 East, said East line being coincident with the West line of the Southwest Quarter of Section 28, Township 27 South, Range 3 East;
66. Thence Easterly 20 feet to the East line of the right of way for Prairie Creek Road;
67. Thence Southerly 30 feet to the South line of said Section 28, Township 27 South, Range 3 East, said South line being coincident with the North line of the Northwest Quarter of Section 33, Township 27 South, Range 3 East;
