

RESOLUTION NO. 25-01

A RESOLUTION OF THE CITY OF ANDOVER, KANSAS AMENDING AND RESTATING CHAPTER 4 OF THE CITY OF ANDOVER POLICY AND GUIDELINES HANDBOOK REGARDING THE PARK LAND AND FACILITY USE POLICY.

WHEREAS, the Governing Body of the City of Andover, Kansas (the "City") finds it necessary to adopt this resolution to update fees for the use of the City's public parks, recreation property and facilities and add Section 7 related to Special Use Approvals.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. Chapter 4 of the City of Andover Policy and Guidelines Handbook is hereby amended and restated, as follows:

4-1 PARK LAND & FACILITY USE POLICY

Res 16-15; 21-10, 25-01

Section 1-Background

The Governing Body of the City of Andover has created a Park Department to establish and maintain an organized, planned, and consistent park use program. Additionally, to establish fees, deposits, and procedures to govern third party use of the City's public parks, recreation property and facilities.

Section 2- Base Reservation Fees & Required Deposits

The City hereby adopts the Base Reservation Fees and Deposit Chart attached hereto as Exhibit "A", which governs the fees, deposits, and rental periods for the City's public parks, recreation property, and facilities ("Base Reservation Fees").

Section 3-Additional Fees

The City Administrator or the City Administrator's designee shall determine all additional fees relating to third party use of the City's public parks, recreation property, and facilities, including but not limited to, clean-up, on-site staff support, furniture setup, and furniture removal ("Additional Fees").

Section 4-Waiver of Fees

The Governing Body may waive Base Reservation Fees and Additional Fees when deemed to be in the public interest.

Section 5-Governing Body and City Employee Use

Except for the Capitol Federal Amphitheater®, the Base Reservation Fees for reservation of the City's public parks, recreation property, and facilities shall be waived for City employees and members of the Governing Body once each calendar year.

Section 6-Facility Use Agreement

All reservations of the City's public parks, recreation properties and facilities shall require a Facility Use Agreement that sets forth the guidelines, regulations and agreements for the reservations ("Facility Use Agreement"). The Facility Use Agreement will be between the City by and through the Andover Parks & Recreation Department and the reserving entity or individual ("Licensee").

Section 7 - Special Use Approvals for the Sale of Goods and Services on Public Property and the Closure of Public Roads

The sale of goods and services, excluding alcoholic or cereal malt beverage sales, on public property can be authorized with the review of three City staff as designated by the City Administrator. In addition to any emergency, law enforcement or public safety authority provided at law, the temporary closure of public roads can be authorized by City staff with the approval of the Police Chief, Fire Chief, and Director of Public Works.


