

RESOLUTION NO. 25-07

A RESOLUTION OF THE CITY OF ANDOVER, KANSAS AMENDING
SEWER SERVICE CHARGE BASE RATES PURSUANT TO CHAPTER XVI,
ARTICLE 8, SUBSECTION 16-802 OF THE CODE OF THE CITY OF
ANDOVER, KANSAS.

WHEREAS, Chapter XVI, Article 8, Subsection 16-802 of the Code of the City of Andover, Kansas (the "Code") authorizes the City of Andover, Kansas (the "City") to establish and amend sewer service charges by determining the base rates from time to time by separate resolution of the Governing Body of the City; and

WHEREAS, the City has determined and declared that it be necessary and conducive to the protection of the public health, safety, welfare, and convenience of the City to collect charges from all users who contribute wastewater to the City's sanitary sewer system; and

WHEREAS, the proceeds of such charges so derived shall be used for the purpose of operating, maintaining, and replacing the sanitary sewer system; and

WHEREAS, the City finds it necessary to adopt this Resolution amending the sewer service charge base rates.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. Pursuant to Chapter XVI, Article 8, Subsection 16-802 of the Code, the Sewer Service Charge Base Rates are hereby established as follows:

- A. Inside city limits is set at \$44.00 and,
- B. Outside city limits is set at \$64.00 both effective upon the billing cycle commencing July 1, 2025
- C. Inside city limits is set at \$48.00 and,
- D. Outside city limits is set at \$68.00 both effective upon the billing cycle commencing July 1, 2026
- E. Inside city limits is set at \$52.00 and,
- F. Outside city limits is set at \$72.00 both effective upon the billing cycle commencing July 1, 2027
- G. Inside city limits is set at \$53.00 and,
- H. Outside city limits is set at \$73.00 both effective upon the billing cycle commencing July 1, 2028

- I. Both Inside and outside city limits is set to increase annually at a rate of 3% effective upon the billing cycle commencing July 1, 2029.

Any fee or service charge not amended in this Resolution shall remain in full force and effect.

SECTION 2.

This Resolution shall supersede any prior resolution establishing the same fees or charges and shall take effect and be in force after its adoption by the Governing Body and publication as required by law.
