In accordance with K.S.A. 12-504, public notice is hereby given that the governing body of the City of Andover, Kansas (the "City") will conduct a public hearing in connection with the consideration and adoption of a vacation and abandonment of the dedicated right-of-way by deed on the following described property, to wit:

**That part of Lot 5, Block 1, Andover Crossing Addition to Andover, Butler County, Kansas, as prepared by Merestone Surveying LLC, CLS-179, surveyors in the aforementioned county and state on November 6th, 2024, being more particularly described as follows:**

**COMMENCING (P.O.C.) at the Northwest Corner of Lot 5, Block 1 of said Andover Crossing Addition, THENCE South 00°00'00" East, along the West line of said Lot 5, a distance of 100.76 feet to the Southwest corner of a tract of land described in Book 2022, Page 7329 as recorded; THENCE South 89°56'10" East along the South line of said tract, a distance of 30.00 feet to the POINT OF BEGINNING (P.O.B.); THENCE North 00°00'00" West, parallel with the West line of said Lot 5, a distance of 48.79 feet to a point 52.00' South of the North line of said Lot 5; THENCE North 90°00'00" East, parallel with the North line of said Lot 5, a distance of 195.74 feet; THENCE South 28°06'40" East, a distance of 55.60 feet to a deflection corner of said tract; THENCE North 89°56'10" West, along the South line of said tract a distance of 221.94 feet to the POINT OF BEGINNING (P.O.B.).**
