ORDINANCE NO. 1970

AN ORDINANCE OF THE CITY OF ANDOVER, KANSAS AMENDING CHAPTER XIX, ARTICLE 5, SECTION 19-525 OF THE CODE OF THE CITY OF ANDOVER, KANSAS REGARDING PENALTY PROVISIONS AND DELINQUENCY TIMING FOR STORM WATER MANAGEMENT FEES.

WHEREAS, the City of Andover, Kansas (the "City") has previously adopted Chapter XIX, Article 5, Section 19-525 of the Code of the City of Andover, Kansas (the "Code") containing provisions relating to penalties for delinquent storm water management fees; and

WHEREAS, the governing body of the City desires, and finds it necessary and advisable, to amend Section 19-525 of Chapter XIX, Article 5 of the Code to amend penalty provisions and delinquency timing for storm water management fees.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. Chapter XIX, Article 5, Section 19-525 of the Code shall be amended and replaced and shall read as follows:

19-525. Penalties.

All users shall be billed monthly. Billings for any month shall be made within fifteen days after the end of that month. Payments are due when billings are made, and any payment not received within fifteen days after the billing is made shall be delinquent. Amounts owed shall be rebilled to the property owner adding thereto a penalty for the increase of collection costs in the amount of 10% of the amount past due for such storm water utility management fee, which penalty shall be in addition to the interest charge of 10% per year permitted by Kansas law, if the same must be certified as an assessment upon the property tax rolls. Nothing herein contained shall be construed to prevent the City of Andover, Kansas from attaching or delivering its statement or statements for the fees and charges made hereunder in conjunction with other fees or charges imposed by said City under the terms of different ordinances.

SECTION 2. This Ordinance amending penalty provisions and delinquency timing for storm water management fees supersedes and repeals any and all previous ordinances to the extent they are in conflict. Any previous ordinance, or provision thereof, to the extent not in conflict with the foregoing shall remain in effect.

SECTION 3. This Ordinance shall take effect and be in full force after its adoption by the governing body of the City, approval by the Mayor and publication once in the official newspaper of the City.
