ORDINANCE NO. 47

AN ORDINANCE DECLARING THE ENTIRE BOUNDARY OF THE CITY OF ANDOVER,
KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY TO THE CITY OF ANDOVER:

Section 1: That the following is a complete legal description of
the present entire boundary of the City of Andover,
Kansas:

Beginning at the Northeast corner of Section 18, Township 27 South, Range 3 East of the 6th P.M., Butler County, Kansas and running thence south to the south line of the Weir Tracts; thence west to the east line of Lot 5, Malcom Tracts; thence south to the north line of Lot 6, Malcom Tracts; thence east to the east line of said Section 18; thence south to the south line of Lot 10, Malcom Tracts extended; thence west to the east line of Lot 13, Malcom tracts; thence south to the north line of Lot 11, Malcom Tracts; thence east to the east section line; thence south to a point 60 feet south of the south line of said Lot 11 extended; thence west to the east line of Lot 19, Malcom Tracts; thence south to the south line of said Section 18; thence west to the west line of said Lot 19; thence north to the north line of said Lot 19; thence west to the east line of Lot 16, Malcom Tracts extended; thence north to the south line of said Lot 16; thence west to the east line of the 2nd Addition to East Central Rolling Acres; thence south to the south section line; thence west to the west line of East Central Rolling Acres; thence north to the north line of East Central Rolling Acres; thence east to the east line of East Central Rolling Acres; thence north to the south line of Lot 6, Jones Tracts; thence west to the west line of Jones Tracts; thence north to the north line of the Southeast Quarter of Section 18, Township 27 South, Range 3 East; thence east to the Southwest corner of the Southeast Quarter of the Northeast Quarter of said Section 18; thence north to the Northwest corner of the Southeast Quarter of the Northeast Quarter of said Section 18; thence east to the west line of Lot 20, Hodges Second Subdivision; thence north to the Northwest corner of Lot 15, Hodges Second Subdivision; thence east 150 feet; thence south 82 feet; thence east along the north line of said Lot 15 to the west line of Main Street; thence north to the north line of Section 18; thence west to the west line of the alley extended west of Church Street; thence north to the south line of Glancey's Reserve in the City of Andover; thence west to the west line of West Street, said line being the west line of the Northeast Quarter of the Southeast Quarter of Section 7, Township 27 South, Range 3 East, Butler County, Kansas; thence north to the Northwest corner of said Northeast Quarter of the Southeast Quarter; thence east to a point 990 feet west of the Northeast corner of the Southeast Quarter of said Section 7; thence north 1,015 feet; thence east to the east section line; thence south to the south right of way line of the St. Louis-San Francisco Railroad; thence easterly along said south right of way to the east line of Heorman's 2nd Addition to the City

of Andover extended, said line being 60 feet east of the east line of Lot 8, Block 3 of said Addition; thence south to the north right of way line of the Kansas Turnpike Authority; thence southwesterly along said north right of way line to the east line of Section 7; thence south along said section line to the place of beginning, being the corporate limits of the City of Andover, Butler County, Kansas.

Section 2: That this ordinance shall take effect and be in force from and after its publication in the official city paper.

Passed by the Governing Body, not less than two-thirds of the members-elect voting in favor thereof, the 11th day of December, 1965.
