

AN ORDINANCE ANNEXING CERTAIN PROPERTIES ADJACENT TO THE CITY OF ANDOVER, KANSAS, AND ENLARGING THE BOUNDARIES THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. That the following described property, all of which is located in Section 18, Township 27 South, Range 3 East, Butler County, Kansas, be annexed to the City of Andover, Kansas:

- (a) Beginning 740 feet North of the SE corner of the NE/4; thence West 270 feet; thence North 134 feet; thence East 270 feet; thence South 134 feet to beginning.
- (b) Beginning 615 feet North and 270 feet West of the SE corner of the SE/4 NE/4; thence West 100 feet; thence North 259 feet; thence East 100 feet; thence South 259 feet to beginning.
- (c) Beginning 615 feet North and 370 feet West of the SE corner of the SE/4 NE/4; thence West 100 feet; thence North 259 feet; thence East 100 feet; thence South 259 feet to beginning.
- (d) Beginning 615 feet North and 470 feet West of the SE corner of the SE/4 NE/4; thence West 100 feet; thence North 259 feet; thence East 100 feet; thence South 259 feet to beginning.
- (e) Beginning 615 feet North and 570 feet West of the SE corner of the NE/4; thence North 259 feet; thence West 150 feet; thence South 259 feet; thence East 150 feet to beginning.
- (f) Beginning 874 feet North and 720 feet West of the SE corner of the SE/4 NE/4; thence South 259 feet; thence West 100 feet; thence North 259 feet; thence East 100 feet to beginning.
- (g) Beginning 615 feet North and 820 feet West of the SE corner of the NE/4; thence North 259 feet; thence West 100 feet; thence South 259 feet; thence East 100 feet to beginning.
- (h) Beginning 874 feet North and 920 feet West of the SE corner of the SE/4 NE/4; thence South 259 feet; thence West 100 feet; thence North 259 feet; thence East 100 feet to beginning.
- (i) Beginning 874 feet North and 1,020 feet West of the SE corner of the SE/4 NE/4; thence South 259 feet; thence West 100 feet; thence North 259 feet; thence East 100 feet to beginning.
- (j) Beginning 874 feet North and 106 feet East of the SW corner of the SE/4 NE/4; thence East 100 feet; thence South 259 feet; thence West 100 feet; thence North 259 feet to beginning.

- (k) Beginning 615 feet North and 1,220 feet West of the SE corner of the SE/4 NE/4; thence North 259 feet; thence West 106 feet; thence South 259 feet; thence East 106 feet to beginning.

SECTION 2. That the boundaries of the City of Andover, Kansas, are enlarged and include the above described real property in accordance with the provisions of K.S.A. 15-11a02 and 1967 Kansas Session Laws, Chapter 98.

SECTION 3. This ordinance shall take effect and be in force from and after its publication in the official paper.
