

ORDINANCE NO. 79

AN ORDINANCE ANNEXING CERTAIN PROPERTIES ADJACENT TO THE CITY OF ANDOVER, KANSAS, AND ENLARGING THE BOUNDARIES THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. That the following described property, all of which is located in Section 18, Township 29 South, Range 3 East of the 6th P.M., Butler County, Kansas, be annexed to the City of Andover, Kansas:

- (a) Beginning 300 feet North of the SE corner of the NE/4; thence West 270 feet; thence North 255 feet; thence East 270 feet; thence South 255 feet to beginning.
- (b) Beginning 555 feet North and 270 feet West of the SE corner of the NE/4; thence South 255 feet; thence West 100 feet; thence North 255 feet; thence East 100 feet to beginning.
- (c) Beginning 555 feet North and 370 feet West of the SE corner of the SE/4 NE/4; thence West 100 feet; thence South 255 feet; thence East 100 feet; thence North 255 feet to beginning.
- (d) Beginning 300 feet North and 470 feet West of the SE corner of the SE/4 NE/4; thence West 100 feet; thence North 255 feet; thence East 100 feet; thence South 255 feet to beginning.
- (e) Beginning 300 feet North and 570 feet West of the SE corner of the SE/4 NE/4; thence West 90 feet; thence North 255 feet; thence East 90 feet; thence South 255 feet to beginning.
- (f) Beginning 555 feet North and 660 feet West of the SE corner of the NE/4; thence South 555 feet; thence West 156 feet; thence North 555 feet; thence East 156 feet to beginning.
- (g) Beginning 555 feet North and 367 feet East of the SW corner of the SE/4 NE/4; thence South 150 feet; thence East 70 feet; thence North 150 feet; thence West 70 feet to beginning.
- (h) Beginning 289 feet East and 277 1/2 feet North of the SW corner of the SE/4 NE/4; thence East 221 feet; thence North 277 1/2 feet; thence West 73 feet; thence South 150 feet; thence West 148 feet; thence South 127 1/2 feet to beginning.
- (i) Beginning 555 feet North and 289 feet East of the SW corner of the SE/4 NE/4; thence South 150 feet; thence East 78 feet; thence North 150 feet; thence West 78 feet to beginning.
- (j) Beginning 555 feet North of the SW corner of the SE/4 NE/4; thence East 66 feet; thence South 277 1/2 feet; thence West 66 feet; thence North 277 1/2 feet to beginning.

- (k) Beginning 132 feet East of the SW corner of the SE/4 NE/4; thence North 555 feet; thence West 66 feet; thence South 555 feet; thence East 66 feet to beginning.
- (l) Beginning 555 feet North and 132 feet East of the SW corner of the SE/4 NE/4; thence East 157 feet; thence South 277 1/2 feet; thence West 157 feet; thence North 277 1/2 feet to beginning.

SECTION 2. That the boundaries of the City of Andover, Kansas, are enlarged and include the above described real property in accordance with the provisions of K.S.A. 15-11a02 and 1967 Kansas Session Laws, Chapter 98.

SECTION 3. This ordinance shall take effect and be in force from and after its publication in the official paper.
