

ORDINANCE NO. 87

AN ORDINANCE ANNEXING CERTAIN PROPERTIES IN SECTION 18, TOWNSHIP 27 SOUTH, RANGE 3 EAST, AS ARE MORE PARTICULARLY DESCRIBED IN SECTION 1 HEREOF, TO THE CITY OF ANDOVER, KANSAS, AND ENLARGING THE BOUNDARIES THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. That the following lands be annexed to the City of Andover, Kansas:

- (a) Malcom Tracts, a subdivision of Butler County, Kansas.
- (b) C.M. Phillips Sub-division of Butler County, Kansas.
- (c) A tract north of Lot 7, Malcom Tracts beginning at the northeast corner of the SE-1/4, SE-1/4, Section 18, T 27 S, R 3 E of the 6th P.M., Butler County, Kansas and running thence west 417.5 feet; thence south 208.75 feet; thence east 417.5 feet to the east section line; thence north to the place of beginning.
- (d) A tract west of Lot 13, 1st Addition to East Central Rolling Acres beginning at the southwest corner of Lot 13, First Addition to East Central Rolling Acres, a subdivision of Butler County, Kansas and running thence west 147.15 feet to the east line of Prosperity Lane; thence north 180 feet; thence east to the northwest corner of said Lot 13; thence south to the place of beginning.
- (e) A tract north of Lot 11, East Central Rolling Acres beginning at the northwest corner of Lot 11, East Central Rolling Acres, a subdivision of Butler County, Kansas and running thence north 220 feet; thence east 145 feet; thence south 220 feet; thence west 145 feet to the place of beginning.
- (f) Part of Prosperity Lane north of East Central Rolling Acres, to-wit: A tract beginning 40 feet north of the northeast corner of Lot 11, East Central Rolling Acres, a subdivision of Butler County, Kansas and running north 180 feet; thence east 40 feet; thence south 180 feet; thence west 40 feet to the place of beginning.
- (g) A tract south of Lot 5, Lakeside Tracts beginning at the southwest corner of Lakeside Tracts, a subdivision of Butler County, Kansas, and running thence east 163.81 feet; thence south 57 feet; thence west 163.81 feet; thence north to the place of beginning.
- (h) A tract south of Lots 16, 17 and 18, Malcom Tracts beginning 660 feet west of the southeast corner of Section 18, T 27 S, R 3 E, Butler County, Kansas and running thence north 660 feet; thence west 330 feet; thence south 660 feet; thence east to the place of beginning

- (i) The First Addition to C.M. Phillips Subdivision in Butler County, Kansas.
- (j) East Central Rolling Acres, a subdivision of Butler County, Kansas.
- (k) Lakeside Tracts, a subdivision of Butler County, Kansas.

SECTION 2. That the boundaries of the City of Andover, Kansas, are enlarged to include the above described real property in accordance with the provisions of K.S.A. 15-11a02 and K.S.A. 1967 Supp. 12-519 et seq.

SECTION 3. That the invalidity of the annexation of any tract or land in Section 1 hereof shall not affect the validity of the annexation of the remaining tracts or lands in said section.

SECTION 4. This ordinance shall take effect and be in force from and after its publication in the official paper.
