

ORDINANCE NO. 89

AN ORDINANCE ANNEXING CERTAIN LANDS IN SECTIONS 18 and 20, TOWNSHIP 27 SOUTH, RANGE 3 EAST, AS ARE MORE PARTICULARLY DESCRIBED IN SECTION 1 HEREOF, TO THE CITY OF ANDOVER, KANSAS, AND ENLARGING THE BOUNDARIES THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. That the following lands be annexed to the City of Andover, Kansas:

- (a) Beginning at the southwest corner of Lot 5, Lakeside Tracts, a Subdivision of Butler County, Kansas and running thence east 163.81 feet to the west line of First Addition to C.M. Phillips Subdivision; thence south 57 feet; thence west to the west line of the SE-1/4 of Section 18, T 27 S, R 3 E, Butler County, Kansas; thence north to the place of beginning.
- (b) Beginning 57 feet south of the southwest corner of Lot 5, Lakeside Tracts, a Subdivision of Butler County, Kansas and running thence east to the west line of First Addition to C.M. Phillips Subdivision; thence south 160 feet; thence west to west line of the SE-1/4 of Section 18, T 27 S, R 3 E, Butler County, Kansas; thence north to the place of beginning.
- (c) Beginning 217 feet south of the southwest corner of Lot 5, Lakeside Tracts, a Subdivision of Butler County, Kansas and running thence east to the west line of First Addition to C.M. Phillips Subdivision; thence south 150 feet; thence west to the west line of the SE-1/4 of Section 18, T 27 S, R 3 E, Butler County, Kansas; thence north to the place of beginning.
- (d) Beginning 367 feet south of the southwest corner of Lot 5, Lakeside Tracts, a Subdivision of Butler County, Kansas and running thence east to the west line of First Addition to C.M. Phillips Subdivision; thence south 150 feet; thence west to the west line of the SE-1/4 of Section 18, T 27 S, R 3 E, Butler County, Kansas; thence north to the place of beginning.
- (e) Beginning 517 feet south of the southwest corner of Lot 5, Lakeside Tracts, a Subdivision of Butler County, Kansas and running thence east to the west line of First Addition to C.M. Phillips Subdivision; thence south to the south line of Section 18, T 27 S, R 3 E, Butler County, Kansas; thence west to the southwest corner of the SE-1/4 of said Section 18; thence north to the place of beginning.

- (f) Thomas Acres, a Subdivision of Butler County, Kansas except Lots 1, 2, 10, 11, 16, 17, 18, 19, 24, 25, 26, 27, 32 and 33 thereof.
- (g) Golden Spur Second Addition to Butler County, Kansas.
- (h) Beginning 267.5 feet north of the southeast corner of Section 18, T 27 S, R 3 E of the 6th P.M., Butler County, Kansas and running west 332 feet, north 120 feet, east 332 feet, south to the place of beginning.
- (i) Beginning at the southeast corner of Section 18, T 27 S, R 3 E of the 6th P.M., Butler County, Kansas and running west 332 feet, north 267.5 feet, east to the east line of Section 18, south to the place of beginning.

SECTION 2. That the boundaries of the City of Andover, Kansas, are enlarged to include the above described real property in accordance with the provisions of K.S.A. 15-11a02 and K.S.A. 1967 Supp. 12-519 et seq.

SECTION 3. That the invalidity of the annexation of any tract or land in Section 1 hereof shall not affect the validity of the annexation of the remaining tracts or lands in said section.

SECTION 4. This ordinance shall take effect and be in force from and after its publication in the official paper.
