AN ORDINANCE PROVIDING FOR THE CREATION OF LATERAL SEWER DISTRICT NO. A-68 IN THE CITY OF ANDOVER, KANSAS, AUTHORIZING THE CONSTRUCTION OF CERTAIN SEWERS THEREIN AND PROVIDING FOR THE PAYMENT OF THE COST THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. That the following described territory in the City of Andover, Kansas, shall constitute and shall hereafter be known as Lateral Sewer District No. A-68, to wit:

Beginning 60 feet north and 816 feet west of the southeast corner of the Northeast Quarter of Section 18, T 27 S, R 3 E, Butler County, Kansas, and running thence west 298 feet; thence north 217.5 feet; thence east 298 feet; thence south 217.5 feet to the place of beginning, all in the City of Andover, Butler County, Kansas.

SECTION 2. That it is hereby deemed necessary that the following sewers with the necessary appurtenances be constructed and the same are hereby ordered constructed in said Lateral Sewer District No. A-68, to wit:

Lateral Sewer Line beginning with an 8-inch pipe sewer 375 feet south of 10th Street and 1,000 feet west of El Dorado Street in the City of Andover, Kansas, and running east 225 feet; thence north 400 feet, there to connect with existing sanitary sewer, to be known for sewage purposes as Lateral A-68.

All of the above and foregoing lines of sewers lying wholly within the corporate limits of the City of Andover, Kansas.

SECTION 3. That the cost of constructing the sewers in said Lateral Sewer District A-68 as set forth in Section 2 of this ordinance shall be charged to the lots, parcels and pieces of ground in said sewer district according to the special benefits accruing to the respective tracts and special assessments therefor shall be levied against said properties payable in 20 annual installments; provided, however, that the owner of any such tract shall have the right to pay the assessment within thirty days and all tracts on which the assessments are so paid in cash within thirty days shall not thereafter be liable for the cost of such sewers. To provide funds to pay the unpaid balance of the cost of such sewers internal improvement bonds of the city shall be issued as provided by law.

SECTION 4. That to provide funds to finance temporarily the cost of making the improvements authorized in this ordinance until the sale of bonds to be issued therefor, there shall be issued temporary improvement notes of the City of Andover, Kansas, the aggregate amount of which shall not exceed \$3,470.00, the estimated cost of said project. Said temporary notes shall be issued from time to time upon resolutions adopted by the governing body of the city, fixing the dates, terms, denominations, interest rates and maturity dates (not exceeding four years from the dates of said notes and redeemable at any time before maturity) as funds are needed and required for carrying on said improvement project; and the Mayor and City Clerk are hereby authorized and directed to prepare and execute each and all of said notes in accordance with the terms of this ordinance and of the said resolutions providing for the same, and the governing body of said city may deliver said notes to persons having claims against the city in connection with the making of said improvements or sell the same at private sale at not less than par and accrued interest; and the proceeds of said notes shall be applied to the payment of actual costs and expenses in connection with the making of said improvements.

SECTION 5. That this ordinance shall take effect and be in force from and after its passage, approval and publication once in the Western Butler County Times, the official city paper.
