

Publ. Oct. 17,(Corrected) ORDINANCE NO. 94

AN ORDINANCE LEVYING AND ASSESSING SPECIAL ASSESSMENTS ON CERTAIN LOTS AND PIECES OF GROUND LIABLE FOR SUCH ASSESSMENTS TO PAY THE COST OF SEWER IMPROVEMENTS IN THE CITY OF ANDOVER, KANSAS, AUTHORIZED IN ORDINANCE NO. 93 AND PROVIDING FOR THE COLLECTION OF SUCH ASSESSMENTS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER,
KANSAS:

SECTION 1. That for the purpose of paying the cost of sewer improvements authorized in Ordinance No. 93 there is hereby levied and assessed against the property liable therefor the several amounts set forth below following the description of each lot or parcel of land, to wit:

Beginning 435 ft. east and 60 ft. north of the southwest corner of the SE 1/4, NE 1/4, Section 18, T 27 S, R 3 E, Butler County, Kansas and running north 217.5 feet, east 75 feet, south and west to beginning.	\$873.32
Beginning 362 ft. east and 60 ft. north of the southwest corner of the SE 1/4, NE 1/4, Section 18, T 27 S, R 3 E, Butler County, Kansas and running north 217.5 feet, east 73 feet, south and west to beginning.	\$850.04
Beginning 289 feet east and 60 feet north of the southwest corner of the SE 1/4, NE 1/4, Section 18, T 27 S, R 3 E, Butler County, Kansas and running north 217.5 feet, east 73 feet, south and west to beginning.	\$850.04
Beginning 289 feet east and 60 feet north of the southwest corner of the SE 1/4, NE 1/4, Section 18, T 27 S, R 3 E, Butler County, Kansas and running west 77 feet, north 217.5 feet, east and south to beginning.	\$896.60

SECTION 2. Such amounts so levied and assessed as set forth in Section 1 of this ordinance shall be due and payable from and after the publication of this ordinance; and the City Clerk shall notify the owners of the above-described property so far as known to him of the amounts of their respective assessments and that unless such assessments are paid within thirty days from the publication of this ordinance, bonds will be issued therefor and the City Clerk shall certify to the County Clerk in the same manner and at the same time as other taxes are certified, for a period of twenty years, all of the above assessments which have not been paid within 30 days after the publication of this ordinance, together with interest on such amounts so certified at a rate not exceeding 6 per cent per annum, and such amounts so certified shall be presented on the tax rolls and collected over said period of 20 years, the levy for each year being one- 20th of the principal amount of the assessments plus one year's interest on the amount remaining unpaid.

SECTION 3. This ordinance shall take effect and be in force from and after its passage, approval and publication once in the official city paper.

ORDINANCE NO. 94

AN ORDINANCE LEVYING AND ASSESSING SPECIAL ASSESSMENTS ON CERTAIN LOTS AND PIECES OF GROUND LIABLE FOR SUCH ASSESSMENTS TO PAY THE COST OF SEWER IMPROVEMENTS IN THE CITY OF ANDOVER, KANSAS, AUTHORIZED IN ORDINANCE NO. 93 AND PROVIDING FOR THE COLLECTION OF SUCH ASSESSMENTS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER,
KANSAS:

SECTION 1. That for the purpose of paying the cost of sewer improvements authorized in Ordinance No. 93 there is hereby levied and assessed against the property liable therefor the several amounts set forth below following the description of each lot or parcel of land, to wit:

Beginning 435 ft. east and 60 ft. north of the southwest corner, SE 1/4, NE 1/4, Sec. 18, T 27 S, R 3 E, Butler County, Kansas, and running thence north 217.5 feet; east 75 feet; south and west to the place of beginning	873.32
Beginning 289 feet east and 60 feet north of the southwest corner, SE 1/4, NE 1/4, Sec. 18, T 27 S, R 3 E, Butler County, Kansas, and running north 217.5 feet, east 1 ⁴ 6 feet, south and west to place of beginning	1,700.07
Beginning 289 feet east and 60 feet north of the southwest corner, SE 1/4, NE 1/4, Sec. 18, T 27 S, R 3 E, Butler County, Kansas, and running west 77 feet, north 217.5 feet, east and south to place of beginning	396.61

SECTION 2. Such amounts so levied and assessed as set forth in Section 1 of this ordinance shall be due and payable from and after the publication of this ordinance; and the City Clerk shall notify the owners of the above-described property so far as known to him of the amounts of their respective assessments and that unless such assessments are paid within thirty days from the publication of this ordinance, bonds will be issued therefor and the City Clerk shall certify to the County Clerk in the same manner and at the same time as other taxes are certified, for a period of twenty years, all of the above assessments which have not been paid within 30 days after the publication of this ordinance, together with interest on such amounts so certified at a rate not exceeding 6 per cent per annum, and such amounts so certified shall be presented on the tax rolls and collected over said period of 20 years, the levy for each year being one- 20th of the principal amount of the assessments plus one year's interest on the amount remaining unpaid.

SECTION 3. This ordinance shall take effect and be in force from and after its passage, approval and publication once in the official city paper.
