

ORDINANCE NO. 98

AN ORDINANCE ANNEXING CERTAIN LANDS IN SECTIONS 17, 18 and 20, TOWNSHIP 27 SOUTH, RANGE 3 EAST, AS ARE MORE PARTICULARLY DESCRIBED IN SECTION 1 HEREOF, TO THE CITY OF ANDOVER, KANSAS, AND ENLARGING THE BOUNDARIES THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. That the following lands be annexed to the City of Andover, Kansas:

- (a) All of Kansas Turnpike Authority right of way lying within the East Half of the Northeast Quarter (E/2 NE/4) of Section 18, Township 27 South, Range 3 East, Butler County, Kansas.
- (b) A tract beginning 587 feet east of the northwest corner of the East Half of the Northeast Quarter (E/2 NE/4) of Section 18, Township 27 South, Range 3 East, Butler County, Kansas; thence east 150 feet; thence south 290 feet; thence west 150 feet; thence north 290 feet to the place of beginning.
- (c) A tract beginning 617.33 feet south of the northwest corner of the East Half of the Northeast Quarter (E/2 NE/4) of Section 18, Township 27 South, Range 3 East, Butler County, Kansas; thence south 702.67 feet; thence east 587 feet; thence north 1,320 feet; thence west 146 feet; thence south 592.33 feet; thence southwesterly to a point 25 feet south and 25 feet west of the last described point; thence west 416 feet to the place of beginning.
- (d) A tract beginning 208.71 feet south of the northwest corner of the Southwest Quarter (SW/4) of Section 17, Township 27 South, Range 3 East, Butler County, Kansas, and running thence east 208.71 feet; thence south 417.42 feet; thence west 208.71 feet; thence north 417.42 feet to the place of beginning.
- (e) A tract beginning on the center line of Sunflower Lane in Willowbrook Second Addition, Butler County, Kansas, thence 320 feet southerly along said center line from the south line of Waterman Street and running thence easterly radial to the curve on Sunflower Lane a distance of 470 feet; thence at a deflection angle to the right of 90° a distance of 120 feet; thence at a deflection angle to the right of 90° to the center line of Sunflower Lane; thence northerly along said center line to the place of beginning.

SECTION 2. That the boundaries of the City of Andover, Kansas, are enlarged to include the above described real property in accordance with the provisions of K.S.A. 15-11a02 and K.S.A. 1967 Supp. 12-519 et seq.

SECTION 3. That the invalidity of the annexation of any tract or land in Section 1 hereof shall not affect the validity of the annexation of the remaining tracts or lands in said section.

SECTION 4. This ordinance shall take effect and be in force from and after its publication in the official paper.
