AN ORDINANCE ANNEXING CERTAIN LANDS IN SECTION 8, TOWNSHIP 27 SOUTH, RANGE 3 EAST, AS ARE MORE PARTICULARLY DESCRIBED IN SECTION 1 HEREOF, TO THE CITY OF ANDOVER, KANSAS, AND ENLARGING THE BOUNDARIES THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. That the following lands be annexed to the City of Andover, Kansas:

Beginning at a point 638.20 feet east and 50.0 feet north of the southwest corner of the SW $\frac{1}{4}$ of Section 8, T 27 S, R 3 E of the 6th P.M., Butler County, Kansas; thence east 2,003.32 feet to a point 50.0 feet north of the southeast corner of said SW $\frac{1}{4}$; thence north along the east line of said SW $\frac{1}{4}$ a distance of 784.52 feet to the southwesterly right of way line of the St. Louis and San Francisco Railroad; thence northwesterly along the southwesterly right of way line of said Railroad a distance of 1,016.09 feet, more or less, to a point 255 feet southeasterly at right angles to the center line survey of the Kansas Turnpike at Station 5402 + 72.53; thence southwesterly and parallel to said center line a distance of 442.90 feet, more or less, to a point 255 feet southeasterly at right angles to said center line at Station 5398 + 29.63; thence southerly 45.25 feet to a point 295 feet southeasterly at right angles to said center line at Station 5398 + 08.47'; thence southwesterly and parallel to said center line a distance of 608.47 feet; thence northwesterly and normal to the northeasterly tangent of a curve whose point of intersection is at Station 5390 + 41.30 of said center line survey, for a distance of 40.0 feet to a point 255 feet southeasterly at right angles to said tangent; thence southwesterly and parallel to said tangent a distance of 150.74 feet to a point on a line projected through said point of intersection and the radius point of said curve; thence northwesterly along said projected line a distance of 10.43 feet to a point; thence deflecting left 146 degrees, 31 minutes and 45 seconds, a distance of 646.18 feet to the point of beginning.

SECTION 2. That the boundaries of the City of Andover, Kansas, are enlarged to include the above described real property in accordance with the provisions of K.S.A. 15-11a02 and K.S.A. 1967 Supp. 12-519 et seq.

SECTION 3. That the invalidity of the annexation of any tract or land in Section 1 hereof shall not affect the validity of the annexation of the remaining tracts or lands in said section.

SECTION 4. This ordinance shall take effect and be in

force from and after its publication in the official paper.
