ORDINANCE NO. 148

AN ORDINANCE REGULATING THE MOTOR VEHICULAR TRAFFIC IN THE CITY OF ANDOVER, KANSAS BY PROVIDING A GENERAL SPEED LIMIT FOR ALL STREETS AND ALLEYS IN SAID CITY AND PROVIDING CERTAIN EXCEPTIONS THERETO, AND DEFINING SCHOOL ZONES in said city, AND PROVIDING FOR A SPEED LIMIT THEREIN AND PROVIDING PENALTIES FOR THE VIOLATION OF ANY SECTION OF SAID ORDINANCE

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, AKNSAS:

Section 1. That from and after the passage of this ordinance and its publication in the official city paper, it shall be unlawful for any person to operate a motor vehicle on any street or alley in the City of Andover, Kansas, at a speed in ~~excess~~ of 25 miles per hour, excepting that portion of such streets upon which a higher speed is permitted as more specifically defined in Section 2 of this ordinance.

Section 2. That from and after the enactment of this ordinance it shall be unlawful for any person to operate a motor vehicle upon any of the following portions of streets in the City of Andover, Kansas, at speeds in excess of those established for each portion of such streets, as follows:

- A. On Andover Road from the South City Limits line Northward to the North line of Rhondda Street - 45 miles per hour.
- B. Andover Road from the North line of Rhondda Street to the South line of Thirteenth Street - 40 miles per hour.
- C. South line of Thirteenth Street to the North City limits line, excepting therefrom that portion designated as a school zone - 30 miles per hour.
- D. All of Central Avenue - 40 miles per hour.
- E. All of Thirteenth Street - 30 miles per hour.

Section 3. For the purpose of regulating motor vehicular traffic the following portions of the following streets are hereby designated as school zones.

- A. Andover Road from the North City Limits to the South line of Lafayette Street.
- B. Main Street from the North line of Wagner Street to the South line of the turnpike right-of-way.

and that such zones shall be in force from 7:30 A.M. to 9:00 A.M. and from 3:00 P.M. to 4:30 P.M. Monday through Friday of each week, and that in such areas designated as school zones and at such times as hereinabove designated, it shall be unlawful to

operate a motor vehicle in excess of 20 miles per hour.

Section 4. That any person found guilty of the violation of any of the terms of this ordinance may be fined not less than \$1.00 or more than \$100.00, and sentenced <sup>to</sup> to serve 30 days in jail, or both such fine and imprisonment.

Section 5. That should any Section or portion of Section of this ordinance be determined illegal or unconstitutional, the remaining section or portions of sections of such ordinance shall be in full force and effect notwithstanding such illegality or lack of constitutionality.

The above ordinance duly passed and adopted by the Governing Body of the City of Andover, Kansas, this 29<sup>th</sup> day of December, 1970.
