ORDINANCE NO. 158

AN ORDINANCE ENACTED PURSUANT TO THE PROVISIONS OF K.S.A. 1969 SUPP. 12-520 (f) ANNEXING A CERTAIN TRACT OF UNPLATTED LAND LYING IN THE SOUTHEAST QUATER OF THE SOUTHWEST QUARTER OF SECTION 18, TOWNSHIP 27 SOUTH, RANGE 3 EAST, TO THE CORP~~RATE~~ LIMITS OF THE CITY OF ANDOVER, KANSAS, MORE THAN 2/3 OF THE BOUNDARY OF WHICH ADJOINS THE PRESENT CORPORATE LIMITS OF THE SAID CITY AND WHICH TRACT IS NOT IN EXCESS OF 20 ACRES

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

Section 1 That there is hereby annexed into the City of Andover, Kansas, with the consent of the landowners, the following described real property located in Butler County, Kansas, to-wit:

Beginning at the Southwest corner of the Southeast Quarter (SE $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Eighteen (18), Township Twenty-seven (27) South, Range Three (3) East; thence North 379.74 feet on the West line of the Southeast Quarter (SE $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of said Section 18; thence Northeast 1609.68 feet to a point on the East line of the Southwest Quarter (SW $\frac{1}{4}$ ) of said Section 18; thence South 414.47 feet on the East line to a point 689 feet North of the Southeast corner of the Southwest Quarter (SW $\frac{1}{4}$ ) of said Section 18; thence Southwest 1555.75 feet to a point on the South line of said Section 18; thence West on South line 48.28 feet to the point of beginning. The same being known as Womer's Addition to the City of Andover, Kansas

Section 2. That the said land annexed in Section 1 of this ordinance is not more than 20 acres, and more than 2/3 of its boundary lines adjoin the present corporate limits of the City of Andover, Kansas.

The above ordinance duly passed and adopted by the Governing Body of the City of Andover, Kansas, this 14<sup>th</sup> day of <sup>August</sup> July, 1971.
