ORDINANCE NO. 169

AN ORDINANCE DECLARING AN EMERGENCY AND SUSPENDING THE EFFECT OF ORDINANCE NO. 147 OF THE CITY OF ANDOVER, KANSAS, AND ENACTED PURSUANT TO THE PROVISIONS OF K.S.A. 1969 SUPP. 12-520(g), ANNEXING A CERTAIN TRACT OF UNPLATTED LAND LYING IN THE NORTHWEST QUARTER OF SECTION SEVENTEEN, TOWNSHIP TWENTY-SEVEN, RANGE THREE EAST TO THE CORPORATE LIMITS OF THE CITY OF ANDOVER, KANSAS WHICH LAND IS ANNEXED WITH THE CONSENT OF THE OWNERS THEREOF, SUCH TRACT BEING A TRACT LYING IMMEDIATELY WEST OF ANOTHER TRACT ANNEXED BY ORDINANCE NO. 162 AS PASSED AND ADOPTED BY THE GOVERNING BODY ON THE 25TH DAY OF JANUARY, 1972.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

Section 1. That for the purpose of this Ordinance an emergency is hereby declared and the first reading of this Ordinance suspended as might otherwise be required by Ordinance No. 147 of the City of Andover, Kansas enacted on the 10th day of November, 1970.

Section 2. That there is hereby annexed to the City of Andover, Kansas the following described real property located in Butler County, Kansas, to-wit:

Commencing at a point 30 feet North and 660 feet West of the Northeast Corner of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Seventeen (17), Township Twenty-Seven (27), Range Three (3) East, thence West 660 feet, thence South approximately 1350 feet to the South line of the North Half (N $\frac{1}{2}$ ) of the said Northwest Quarter (NW $\frac{1}{4}$ ), thence East for a distance of approximately 660 feet to a point due South of the point of commencement, thence North approximately 1350 feet to the point of commencement;

which tract lies immediately West of a tract of land annexed by Ordinance No. 162 of said City as passed and adopted on the 25th day of January, 1972.

Section 3. That the said land annexed by Section 2 of this Ordinance is annexed with the consent, in writing, of the owners thereof.


