ORDINANCE NO. 170

AN ORDINANCE DECLARING AN EMERGENCY AND SUSPENDING THE EFFECT OF ORDINANCE NO. 147 OF THE CITY OF ANDOVER, KANSAS, AND ENACTED PURSUANT TO THE PROVISIONS OF K.S.A. 1969 SUPP. 12-520(g), ANNEXING A CERTAIN TRACT OF UNPLATTED LAND LYING IN THE SOUTHWEST QUARTER OF SECTION EIGHTEEN, TOWNSHIP TWENTY-SEVEN, RANGE THREE EAST OF THE OF THE CORPORATE LIMITS OF THE CITY OF ANDOVER, KANSAS WHICH LAND IS ANNEXED WITH THE CONSENT OF THE OWNERS THEREOF AND IS NOT IN EXCESS OF TWENTY ACRES

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

Section 1: That for the purpose of this Ordinance an emergency is hereby declared and the first reading of this Ordinance suspended as might otherwise be required by Ordinance No. 147 of the City of Andover, Kansas enacted on the 10<sup>th</sup> day of November, 1970.

Section 2: That there is hereby annexed to the City of Andover, Kansas the following described real property located in Butler County, Kansas, to-wit:

Beginning at a point 30 feet South of the Southwest Corner (SW/C) of the Southeast Quarter (SE $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Eighteen (18), Township Twenty-Seven (27), Range Three (3) East, thence West 30 feet, thence North 409.74 feet, thence East 30 feet, thence South 409.74 to point of beginning.

Section 3: That the said land annexed by Section 2 of this Ordinance is not more than twenty acres and the same is annexed with the consent, in writing, of the owners thereof.

The above Ordinance duly passed and adopted this 25<sup>th</sup> day of April, 1972.
