ORDINANCE NO. 205

AN ORDINANCE DECLARING AN EMERGENCY AND SUSPENDING THE EFFECT OF ORDINANCE NO. 147 OF THE CITY OF ANDOVER, KANSAS, AND ENACTED PURSUANT TO THE PROVISIONS OF K.S.A. 1969 SUPP. 12-520(g), ANNEXING A CERTAIN TRACT OF UNPLATTED LAND LYING IN THE NORTHWEST QUARTER OF SECTION SEVENTEEN, TOWNSHIP TWENTY-SEVEN SOUTH, RANGE THREE (3) EAST TO THE CORPORATE LIMITS OF THE CITY OF ANDOVER, KANSAS WHICH LAND IS ANNEXED WITH THE CONSENT OF THE OWNERS THEREOF

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

Section 1. That for the purpose of this Ordinance an emergency is hereby declared and the first reading of this Ordinance suspended as might otherwise be required by Ordinance No. 147 of the City of Andover, Kansas enacted on the 10th day of November, 1970.

Section 2. That there is hereby annexed to the City of Andover, Kansas the following described real property located in Butler County, Kansas, to-wit:

East Half ( $E\frac{1}{2}$ ) of the West Half ( $W\frac{1}{2}$ ) of the Northwest Quarter ( $NW\frac{1}{4}$ ) of the Northwest Quarter ( $NW\frac{1}{4}$ ) of Section Seventeen (17), Township Twenty-seven (27) South, Range Three (3) East of the 6th P.M.

Section 3. That the said land annexed by Section 2 of this Ordinance is annexed with the consent, in writing, of the owners thereof.

The above Ordinance duly passed and adopted this 13<sup>th</sup> day of October, 1973.
