ORDINANCE NO. 211

AN ORDINANCE DECLARING AN EMERGENCY AND SUSPENDING THE EFFECT OF ORDINANCE NO. 147 OF THE CITY OF ANDOVER, KANSAS; AND AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF GENERAL OBLIGATION IMPROVEMENT BONDS OF THE CITY OF ANDOVER, KANSAS, THE SAME BEING DESIGNATED "SERIES GS-1974-A", IN THE AGGREGATE PRINCIPAL SUM OF \$100,000.00 TO PAY THE ACCRUED AND ACCRUING COSTS OF FURNISHING A PORTION OF THE SYSTEM OF DISPOSAL WORKS FOR THE PURIFICATION OF SEWAGE OF THE CITY OF ANDOVER, KANSAS, UNDER THE AUTHORITY OF K.S.A. 1973 SUPPLEMENT, AND PURSUANT TO ARTICLE 1 OF CHAPTER 10, OF THE KANSAS STATUTES ANNOTATED, THE SAME BEING KNOWN AS THE "GENERAL BOND LAW", AND ALL AMENDMENTS THERETO.

WHEREAS, The City of Andover, Butler County, Kansas has heretofore by official action of its Governing Body, declared it necessary to construct a system of disposal works for the purification of the sewage of said City of Andover, Butler County, Kansas; and,

WHEREAS, Said City of Andover, Butler County, Kansas has full authority under K.S.A. 1973 Supp. 12-621, and Article 1 of Chapter 10 of Kansas Statutes Annotated, and acts amendatory thereof and supplementary thereto, to issue it's General Obligation Improvement Bonds (Sewage Disposal Plant Bonds), of the City of Andover, Butler County, Kansas, in the sum of \$100,000.00, for the purpose of paying for a system of disposal works for the purification of the sewage of said City, said system of disposal works to cost approximately \$100,000.00, and,

WHEREAS, Said City at large is liable for the payment of said cost; and,

WHEREAS, All legal requirements, as provided in the statutes of the State of Kansas have been fully complied with, with reference to the construction of a Sewage Disposal Works, and the issuance of bonds to pay the cost of constructing said Sewage Disposal Works;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, BUTLER COUNTY, KANSAS:

Section 1. That the City of Andover, Butler County, Kansas, construct a system of disposal works for the purification of the sewage of said City.

Section 2. That for the purpose of paying for a system of disposal works for the purification of the sewage of said City, there shall be and hereby are, issued General Obligation Improvement Bonds, "Series GS-1974-A" , of the City of Andover, Kansas, in the aggregate amount of \$100,000.00, which said issue shall consist of 100 bonds, numbered from 1 to 100 ,both inclusive, in the denomination of \$1,000.00 each, shall be dated April 1, 1974, and shall bear interest and mature according to the following schedule:

Said interest being payable on the first day of April, 1975, and on the first day of October and April thereafter each year until said principal sum having been paid.

Section 3. Said bonds and coupons shall contain recitals, and be in the form and of the size as provided by the statutes of the State of Kansas.

Section 4. That said bonds shall be signed by the Mayor and attested by the Clerk of said City, and shall have the corporate seal affixed, and the interest coupons shall be signed with the facsimile signatures of said Mayor and City Clerk, and both principal and interest shall be payable at the office of the State Treasurer of the State of Kansas, in the City of Topeka, Kansas.

Section 5. The Mayor and City Clerk are hereby authorized to prepare and execute said bonds and coupons, and, when so executed, said

bonds shall be registered as required by Law, and the Governing Body shall annually make provision for the payment of the principal and interest of said bonds as the same shall become due by levying a tax upon all the taxable property of said City of Andover, Butler County, Kansas, and the full faith and credit of the City of Andover, Kansas is hereby pledged to the prompt payment of both principal and interest on said Bonds.

Section 6. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 7. That this ordinance shall be in full force and take effect from and after its publication in the Andover Journal, the official City paper, as provided by law.
