The City Clerk is hereby authorized, ordered and directed to cause the publication of a Notice of Public Hearing, in the form and manner required by law, in a newspaper of general circulation within the municipality on September 15, 2024 and September 22, 2024, said dates being at least once each week for two consecutive weeks.

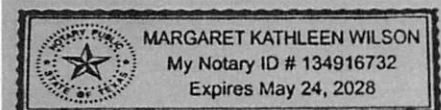
