

RESOLUTION NO. 24-12

A RESOLUTION OF THE CITY OF ANDOVER, KANSAS AUTHORIZING A SPECIAL EVENT ON CITY PROPERTY IN CONNECTION WITH THE HERITAGE DEDICATION EVENT FOR THE CONSUMPTION OF ALCOHOLIC LIQUOR ON PUBLIC PROPERTY WITHIN THE CITY LIMITS.

WHEREAS, the developers of Heritage Park in Andover have issued a closed invitation for a “Special Event” dedication offering the private service of alcoholic liquor to invited guests on Thursday, May 2, 2024 from 5:00 p.m. to 7:00 p.m. in the designated area consisting of Heritage Park, including the Plaza at Heritage Park, Heritage Square and the Skylofts (the “Special Event Premises”); and

WHEREAS, the Special Event Premises is located entirely within the corporate limits of the City; and

WHEREAS, the Special Event Premises includes public property owned by the City (including the designated portion of Heritage Park, which further includes the Plaza at Heritage Park, Heritage Square and the Skylofts), such that the designation of a “Special Event” by the City is required in order to allow consumption of alcoholic beverages pursuant to the Code of the City of Andover, Kansas (the “Code”).

WHEREAS, the Code does not normally allow the consumption of any alcoholic liquor or cereal malt beverage on public property within the City outside of the immediate confines of Heritage Park and the Plaza at Heritage Park, except during “Special Events” of a specified time, place, and duration, upon approval by the governing body of the City; and

WHEREAS, the governing body desires to approve a “Special Event” solely for the purpose of allowing consumption of alcoholic beverages on public property which may be beyond the immediate confines of Heritage Park (including sidewalks and public connecting spaces).

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

SECTION 1. Authorization of Special Event. The City authorizes a “Special Event” on Thursday, May 2, 2024, where guests are authorized to consume alcoholic liquor from 5:00 p.m. to 7:00 p.m., within the Special Event Premises, provided there is compliance with all other requirements of Kansas and local law at all times (the “Special Event”).

SECTION 2. Display of License. This Resolution shall be placed conspicuously at the Special Event Premises by any persons serving alcohol to invited guests.

**SECTION 3. Governing Law and Effective Date.** This Resolution shall be governed by and construed in accordance with the applicable laws of the State of Kansas and shall take effect from and after its adoption and approval.


