ORDINANCE NO. 243

AN ORDINANCE PROVIDING FOR THE ISSUANCE OF INTERNAL IMPROVEMENT BONDS BY THE CITY OF ANDOVER, KANSAS DESIGNATED "SERIES SS-1975-A" IN THE SUM OF \$18,010.45 TO PAY THE COSTS OF THE CONSTRUCTION OF SANITARY SEWER LATERALS IN SANITARY SEWER BENEFIT DISTRICT COMMONLY KNOWN AS S-1975-A, SAID DISTRICT COMPRISED OF ALL OF RESERVE "A" AND LOTS 1 THROUGH 6 IN BLOCK 4, KOOPS TRACTS ADDITION TO THE CITY OF ANDOVER, KANSAS, NONE OF SAID SANITARY SEWER IMPROVEMENT BEING CHARGEABLE TO THE CITY AT LARGE AND ALL OF THE SAME BEING CHARGEABLE TO THE BENEFIT DISTRICT AND THE PROPERTY THEREIN SPECIALLY BENEFITED THEREBY.

WHEREAS, by Resolution adopted on the 29th day of October, 1974 and published on the 12th day of December, 1974, certain sanitary sewer improvements as above described in the caption of this Ordinance, which caption is by this reference made a part of this preamble as fully as if set out herein, have been authorized and are now completed and the total cost of said improvement within the City has been ascertained to be \$18,426.00, of which amount \$551.04 represents accrued interest on a Temporary Note outstanding for said project, and

WHEREAS, the sum of \$415.55 has been paid by one of the properties so assessed and specially benefited, thus leaving the unpaid costs of said improvement in the amount of \$18,010.45, and

WHEREAS, the total costs of said improvement above described is chargeable to the property specially benefited as hereinabove described in said caption and none of said costs is chargeable to the City at large, and

WHEREAS, it is necessary to issue internal improvement bonds of the City of Andover, Kansas to be designated Series "SS-1975-A" to pay the unpaid portion of the costs of said improvement in the said sum of \$18,010.45.

NOW, THEREFORE,

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ANDOVER, KANSAS:

Section 1. That for the purpose of paying the costs of sanitary sewer improvements in Sanitary Sewer District Number S-1975-A in said City as such is more specifically described in the caption and preamble of this Ordinance, which caption and preamble are made a part of this section as fully as if set out herein, such costs being the costs not paid in cash by property owners with the time allowed by law, there shall be issued internal improvement bonds of the City of Andover, Kansas in the aggregate principal amount of \$18,010.45, which bonds shall be dated the 1st day of August, 1975 and shall be designated Series SS-1975-A (the use of a slightly different designation for said improvement bonds as opposed to the designation of the said sewer district shall not be construed to constitute a discrepancy in that the system used by said City in designating sanitary sewer districts and its bonds requires that the bonds be so designated to distinguish the same from subsequent bonds which might be issued in the year 1975), which bonds shall be numbered one through ten inclusive and shall be in the denomination of \$2,000.00 each excepting number one which shall be in the denomination of \$1,010.45 and bond number two which shall be in the denomination of \$1,000.00, and shall bear interest and become due and payable as follows, to-wit:

Interest on said bonds shall be payable on August 1, 1976 and semi-annually thereafter on January and August of each year until the principal sum is paid. Both principal and interest shall be payable at the office of the State Treasurer in the City of Topeka, Kansas.

Section 2. Said bonds shall be in the usual form and contain the usual recitals including a recital that they are issued under the authority of K.S.A. 10-101 through 10-126 inclusive, as amended, and K.S.A. 12-6(a)01 through 12-6(a)18, inclusive, as amended; shall be signed by the Mayor, attested by the City Clerk and shall have the corporate seal of the City affixed thereon. The interest coupons attached thereto shall be printed in accordance with law and shall bear facsimile signatures of the Mayor and City Clerk.

Section 3. The Mayor and City Clerk are hereby authorized, empowered and directed to prepare and execute said bonds and coupons without unnecessary delay, and when executed said bonds and coupons shall be registered by the City Clerk in her office and also in the office of the State Treasurer of the State of Kansas as required by law and delivered to the purchaser thereof and the proceeds of said bonds shall be used for the purpose hereinabove stated. The full faith, credit and resources of the City of Andover, Kansas, are hereby pledged to secure the payment of the principal and interest on said bonds as the same severally become due and payable, and the Governing Body of the City of Andover, Kansas, shall make provision for the payment of said principal and interest by levying an annual tax on the property liable therefor in an amount sufficient to pay the installments of principal and the interest as it accrues and becomes payable.
