**From Les Mangus' Memo:** The proposed wall signage change for the Metro Grill II located at 321 S. Andover Rd. Ste. 100 is within the bulk regulations for the zoning district. Staff supports the application as presented.

Mr. Martine explained that they would like to put up another cabana, very similar to the 2 on the south side of the building. This one will be on the North side of the pool, and will be 20ft. x 40ft.

The face on Andover Road has 2 glass doors in it with stone that will match the stone on the main building to fill in. The back side (North) will have a 6ft. good neighbor fence as the backdrop. The Southside will be open to the pool deck.

Don Kimble asked if this structure would be open on 3 sides with the doors on the West side. Mr. Martine said yes. Doug Allison

asked if there would be any fencing. Mr. Martine said that the North wall would be the fence for the pool, as required, and would be the same as the existing fencing on the property. Don Kimball asked if there would be a concrete floor. Mr. Martine said that the flooring would consist of pavers.
