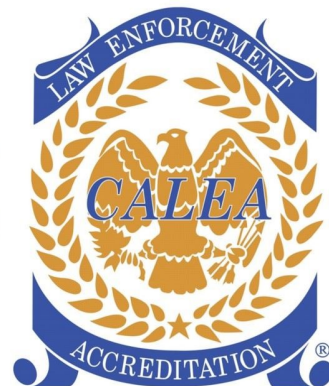

MESSAGE FROM CHIEF BUCK BUCHANAN

Mayor Price, Members of the City Council, City Administrator Jenni McCausland, and Citizens of Andover,

On behalf of our community, and the men and women of the Andover Police Department who make this organization one of the most respected law enforcement agencies in Kansas, I would like to welcome you to the Andover Police Department's 2021 Annual Report. This report showcases the hard work, dedication and accomplishments of the men and women who proudly serve you, the citizens of Andover.

We had another remarkable year and our citizens once again experienced a very low crime rate, well below the state average when compared to cities of similar size. Additionally, in 2021, we experienced; another great Police & Fire Festival; another very successful National Night Out; for the eleventh year in a row, a fantastic Greater Andover Days; and the seventh extremely successful "Fill-A-Cruiser" food drive to support the Andover Food Bank. However, 2021 was also highlighted by the following:

The Department responded to 19,990 calls for service, completed 1,920 incident reports, investigated 235 motor vehicle accidents, issued 1,391 traffic citations and 834 traffic warnings, and made 301 arrests including taking 23 drunk drivers off our streets. With over 23,000 citizen contacts, the professional bearing of our staff resulted in zero citizen complaints in 2021, and an unprecedented five total citizen complaints over the previous 4-years.

The Police Department hired four new officers to our staff, Frank Gomez, James Nelson, Neil Kline and Stepheni Peltier, as well as two new Communications Officers, Colter Henrie and Camille Gregory.

The Police Department had three members retire from the department in 2021, Chief of Police Michael Keller, Lieutenant Daimon Cundiff and Lieutenant Donald Roberson. Chief Michael Keller is Andover's longest serving Police Chief. Chief Keller served the Andover Community from May 14, 2007 to September 24, 2021. Lieutenant Cundiff was with the department from 1997 to 2021, and Lieutenant Donald Roberson also had an exceptional amount of years as well, serving Andover from 2001 to 2021.

For the eleventh year in a row, the Police Department was recognized by the American Automobile Association (AAA) of Kansas for the department's efforts in traffic safety initiatives and the eighth year in a row to receive the "Community Traffic Safety "platinum" award.

Andover is an exceptional city, and the efforts of our police officers, communications officers, civilian support staff, citizens and the steadfast public safety support from Mayor Lawrence and the entire City Council have made a positive impact on the quality of life in our community. Please take a moment to learn more about your nationally accredited Police Department and the services that we provide. You will find that our staff are dedicated, highly trained and passionate professionals who take pride in their work. They are ready to work with you to make Andover an even better place to "live, work and play!"

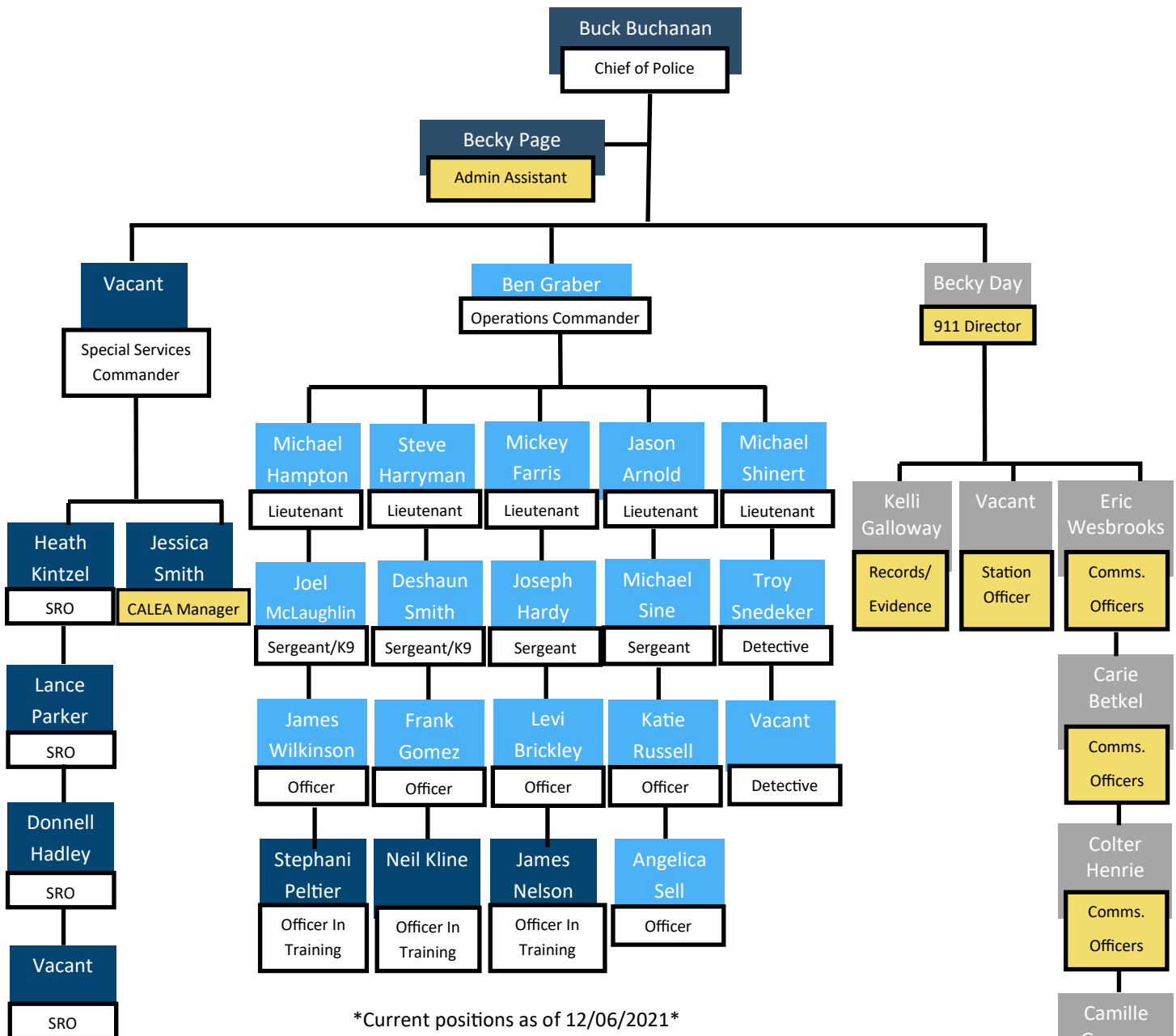

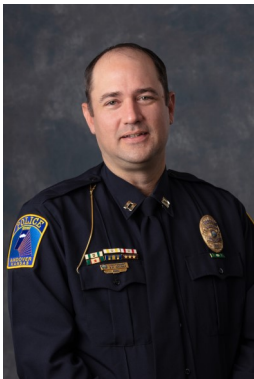


**CHIEF OF POLICE
BUCK BUCHANAN**

Chief Buck Buchanan was appointed as Police Chief of the Andover, Kansas Police Department on September 25, 2021, and began his career in law enforcement as an Andover Police Department Reserve Officer in 1994 and a few months later was hired by the Wichita (KS) police department. In 1997 Chief Buchanan returned to the Andover Police Department as a Reserve Sergeant where he remained for 7-years. In 2004 Chief Buchanan was hired on as a full-time officer, and in 2005 moved to a Part-Time Officer position where he served until 2009. In August of 2009, Chief Buchanan returned to full-time status and was assigned to the Patrol Division as a School Resource Officer. On April 1, 2013, Chief Buchanan was promoted to the rank of Sergeant and in August of 2013 reclassified to the rank Of Lieutenant. On December 31, 2017, Chief Buchanan was promoted to Captain where he served as the Commander of the "Special Services" Division. In January of 2020 Chief Buchanan assumed the role as the department's Operations Commander where he oversaw the day-to-day operations of both the Patrol and Investigations sections until his recent promotion to Chief of Police. Additionally, Chief Buchanan is a Defense Tactics Instructor, ASP Instructor, Active Shooter Instructor, a Child Passenger Safety Seat Technician, and Crisis Negotiators.

Chief Buchanan is a 2013 graduate of the Kansas University Public Management Center's "Command School," a 2016 graduate of the Kansas University Certified Public Manager Program, a 2016 graduate of the Kansas Police Administrators Seminar (KPAS), and a 2017 graduate of the 270th Session of the FBI's National Academy. Chief Buchanan is currently attending Faulkner University pursuing his Bachelor's Degree in Criminal Justice.

Chief Buchanan was the recipient of the 2010 "Officer of the Year" award.

Captain Ben Graber started with the Andover Police Department in June 2008. Captain Graber began his Public Safety career in 1997 when he joined the volunteer fire department in his hometown of Pretty Prairie (KS) where he was promoted to the rank of Captain before leaving. In 2002 he began his law enforcement career with the Reno County Sheriff's Department, starting out as a Jail Deputy before transferring to patrol. 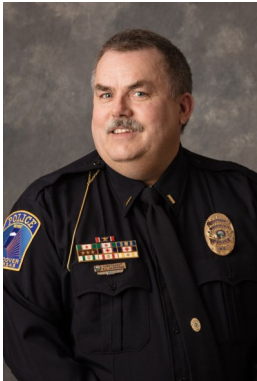

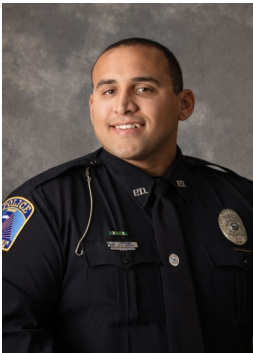

Sgt. Sine is a military veteran where he served four years in the United States Air Force.

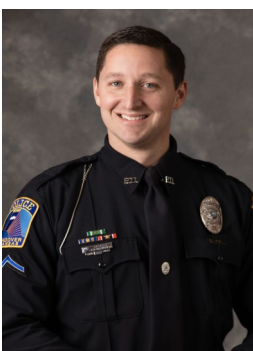

Sgt. Smith holds a Bachelor's Degree in Sociology with a minor in Criminal Justice from Emporia State.



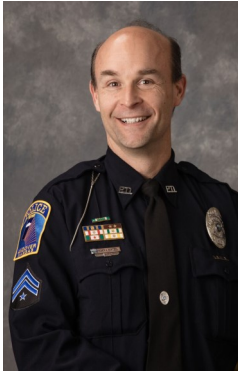

Captain Ben Graber and Lieutenant Michael Hampton nominated Officer Katie Russell for the Life Saving Award of 2021. On August 11, 2021, Officer Russell acted swiftly when a 15-year old girl was brought into the station unresponsive. She administered chest compressions, restoring a weak pulse and breathing. EMS arrived, administering Narcan to revive the girl from a Fentanyl overdose.

Officer Katie Russell's rapid response and effective actions were pivotal in saving the girl's life, confirmed by AFR Capt. Gary Elliot. Recognizing her exceptional contribution, the committee unanimously approved the "Life Saving Award."

In line with General Order M1218, Officer Katie Russell is granted the "Life Saving Award" based on the recommendation of the Awards Board and the Chief of Police's approval.

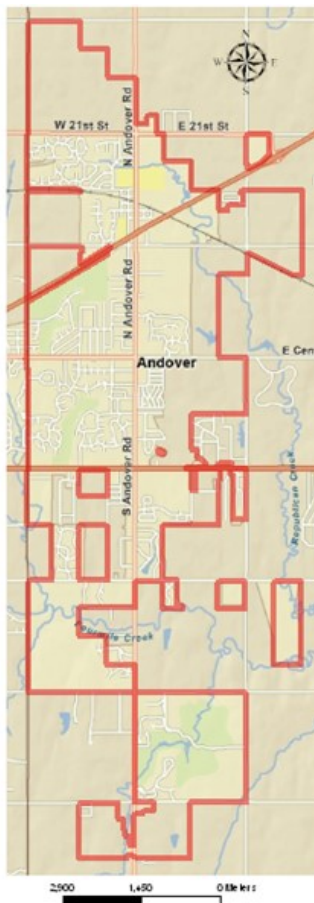

Annually, the Chief of Police will prepare a department budget as directed by the City Administrator and in accordance with the time lines established by the City Administrator. The budget will be for the next fiscal year that begins on January 1st. Prior to the first draft of the budget being due to the City Administrator, Division and Section Commanders will solicit employee suggestions regarding anticipated budgetary needs for the next fiscal year. Division and Section Commanders will incorporate employee suggestions having merit and the Commander's suggestions into written form and submit through proper channels to the Chief of Police to consider and include recommendation for Operating needs, Capitol purchase needs, and Personnel needs. The Chief of Police may choose to meet with Division and Section Commanders throughout the budget process as needed to properly prepare the department budget within the guidelines established by the City Administrator and Governing Body, and within the fiscal capabilities of the department. The Chief of Police will prepare a final budget within the timeline established by City Administrator and will submit for approval to the Governing Body for the next fiscal year that begins January 1st .

STATISTICAL CRIME DATA

Seven serious offenses are used to define trends and make comparisons across the nation. These offenses are called index crimes or Part I Offenses, and data about them are drawn from the Federal Bureau of Investigation's Uniform Crime Reporting (UCR) program. The Andover Police Department has been awarded 11 consecutive Traffic Safety Awards, and received the 8th consecutive "Traffic Safety Platinum Award" in 2021. From 2020 to 2021 the total number of Traffic stops decreased 6.5%, this could possibly be an effect of COVID and less people getting out and more people working from home, or for an undetermined reason. School Zones have always been a big priority for our Officers to keep kids safe, with that in consideration and an increased number of children in Andover, the Citations for School Zones raised 18.3% in 2021. The DUI Arrests dropped 32.4%, possibly from more citizens staying home and businesses being closed due to COVID.

In 2021, the total number of “Calls for Service” increased by 20.4% from the previous year 2020, which is expected from the growing population in Andover. Incident Reports as well as Alarm calls both had an increase in 2021, and Animals calls had a small increase of 4.5% from the previous 2020 year.

Department Complaints

Each year the Andover Police Department conducts an analysis of Use of Force and reviews assaults on sworn officers as part of a comprehensive review process to meet CALEA requirements. In conducting the analysis, all use of force incidents were examined for the 2021 calendar year and all were found to be in compliance with department policies and procedures. In 2021, the Andover Police Department recorded 15,349 calls for service, a 3.44% increase in activity from 2020's 14,839 calls for service. There were a total of 24 applications of force by officers, sixteen (16) of those involved empty hand control tactics on subjects who were physically resisting officers. There were three (3) incidents that involved officers using a Baton to gain control of a subject. There was one (1) incident where a Taser was displayed to gain control of a subject who complied but then fought officers on the ground. There was one (1) incident that involved an officer discharging a firearm to humanely euthanize an injured deer. Finally, there was one (1) incident that involved one officer discharging his duty firearm at a suspect who was attempting to flee from an arrest and driving toward the officer. These numbers are not counted in the overall application of force. In total, force was used in 11 different situations to include on persons and animals. When comparing the statistics, from 2021 to 2020, It was found that we had an increase of 2.54% in total arrests for the agency. Our total use of force incidents decreased to 11 from 27 for a decrease of 59.2%. There were sixteen (16) weaponless incidents, a decrease of 10 from 2020, a 62.5% decrease. Of our agency's 242 arrests, force of some sort was used to combat or prevent resistance in 4.13% of all arrests compared to 10.72% in 2020.

CITIZEN SATISFACTORY SURVEY

The Andover Police Department is committed to providing high quality customer service to citizens. In addition to tracking and documenting citizen complaints, the Police Department also survey's the community on a regular basis, to determine our citizens attitudes and opinions to; overall agency performance; overall competence of agency employees; citizen perceptions of the officer's attitudes and behaviors, community concern over safety within the agency's service area, and citizen's recommendations and suggestions for improvements. The survey is made available to the public via the department's website, printed copies at the station, and a QR code on the back of business cards. The original survey was originally developed and administered in January of 2012, with 582 citizen responses through December of 2022.

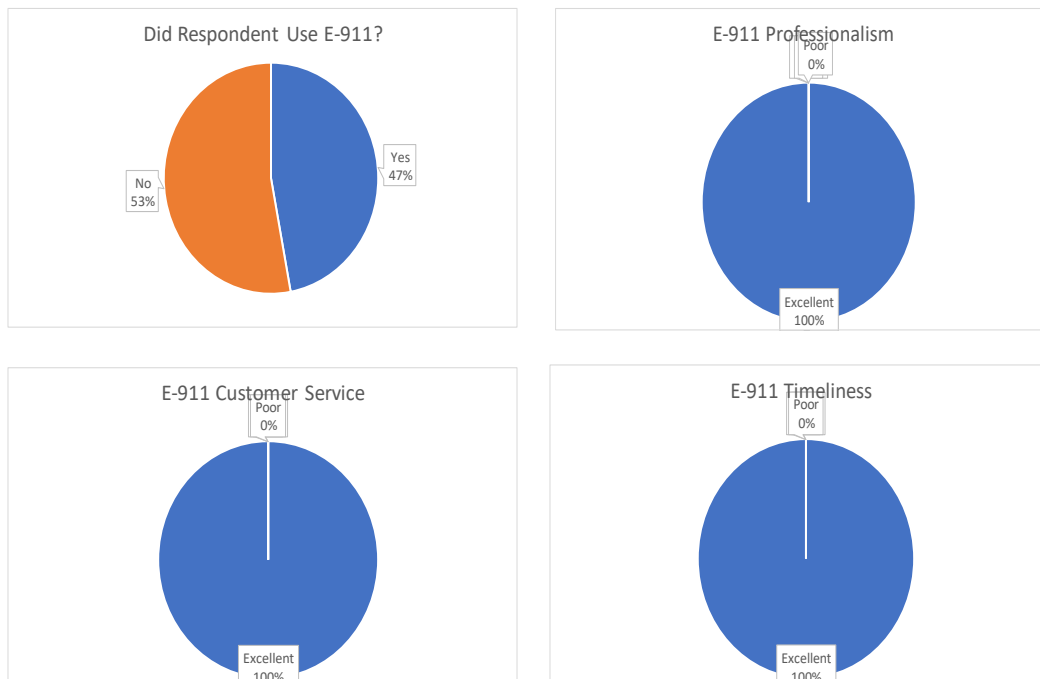
In 2021, Seventeen (17) Citizen Satisfactory Survey's were completed by citizen's. The survey's indicate that approximately 35% were Andover residents, 41% were working in Andover, 6% were traveling through Andover, and 12% indicated they were here for "Other" reasons. Additionally, 12% of respondents indicated they reported a crime, 12% witnessed a crime or incident, 6% reported a problem, 6% requested information/Assistance, 12% received a traffic citation or warning and 53% indicated their nature of contact as "Other."

E-911 Responses

In 2021, Citizen's were asked to rate our E-911 services in the following areas if they had contact with a 911 operator during the nature of their call.

Professionalism | Customer Service | Timeliness | Overall Satisfaction

In 2021, 47% of responses indicated they utilized our E-911 Communications Center. The respondents rated the dispatcher either "Excellent" or "Good," 100% of the time in all areas.

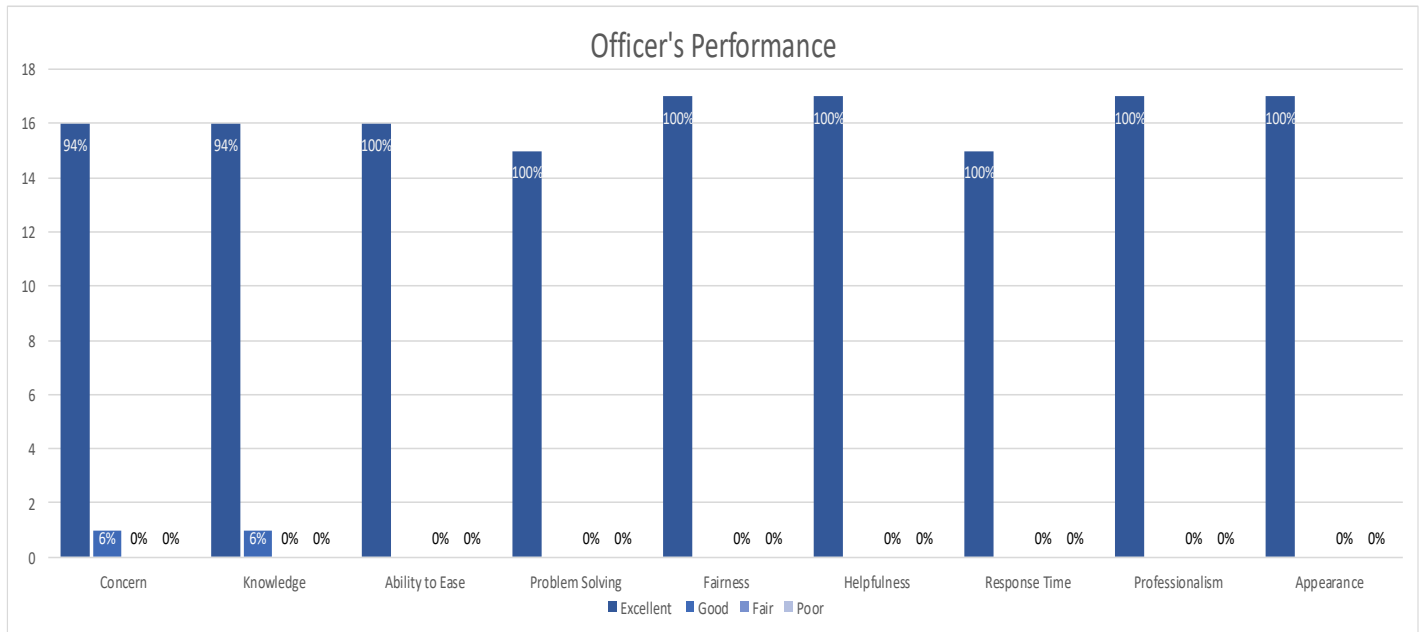

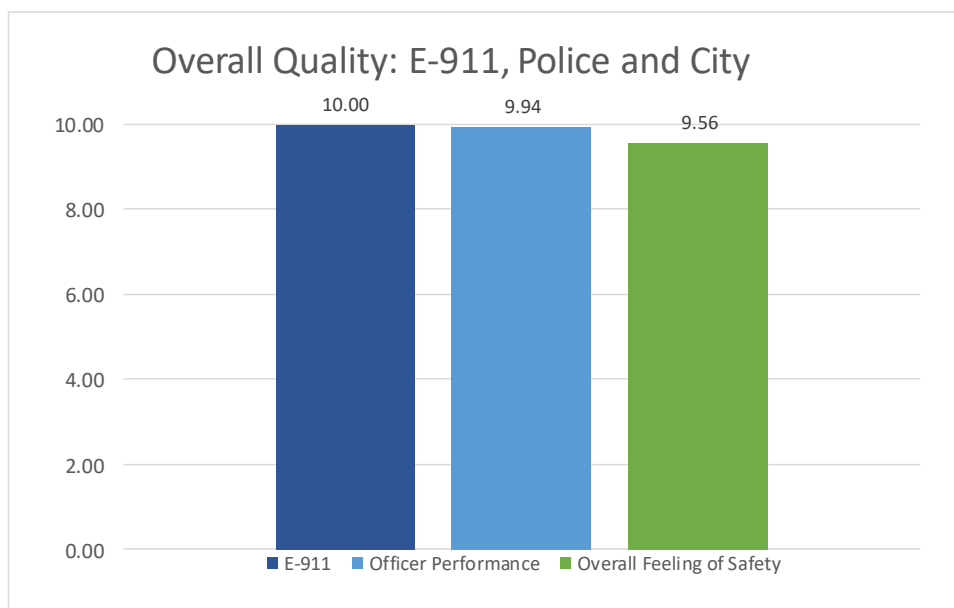
Professionalism | Ability to put at ease | Helpfulness | Appearance

Overall Survey Results

Citizens were asked, on a scale of one to ten, rate their overall Satisfaction with the E-911 Communications Center, the Andover Police Department, and how safe they feel living in the Andover Community. The citizens reported on average a 10 satisfaction rating for E-911 Communications Center, 9.94 on Officer Performance, and 9.56 on feeling safe in Andover.
