Message From The Chief



To Mayor Ronnie Price, Members of the City Council, and the Citizens of Andover,

Each year the Andover Police Department compiles an Annual Report summarizing the work accomplished by the department during the previous year. Among other things, it provides the public an overview of the department, crime data, community interactions, and history. It is a tribute to the men and women of the Police Department, the E-911 Emergency Communications Center, and the Community that they serve.

Our Police Department has enjoyed a great deal of success over the year, based largely on the level of support and cooperation within our community. The citizens of Andover, the City Council, and our staff all continue to share a common goal, to keep our residents and their property safe. 2019 was no different, and I am privileged to be able to work with of committed professionals within this Department, who work hard every single day to make the lives of our citizens in Andover better.

The 2019 Andover Police Department's Annual Report highlights the dedication to excellence and more importantly, the continued commitment to provide "public service excellence" and responsive police services to the citizens and visitors of this great city. This report provides an overview of services provided by the Police Department and Emergency Communications Center in 2019, and the activities that they engaged in within the community.

The 2019 Highlights include:

- The City of Andover once again experienced a drop in crime, and a very low crime rate, boasting less than 1 violent crime and just over 23 property crimes per 1,000 residents, well under both state and federal averages, and was recognized in January as the 5th safest City in Kansas by the National Council for Home Safety and Security, in August as the 2nd safest City in Kansas by "Backgroundchecks.org," and in September as the 38th best city in the country to live by USA Today.
- The Department responded to 21,873 calls for service, completed 1,682 incident reports, investigated 260 motor vehicle accidents, issued 1,618 traffic citations and another 1,218 traffic warnings, and made 260 arrests including taking 21 drunk drivers off our streets. With well over 22,000 citizen contacts, the professional bearing of our staff resulted in one citizen complaint in 2019, and an unprecedented, five complaints over the previous 3-years.
- For the ninth year in a row, the Police Department was recognized by the American Automobile Association (AAA) of Kansas for the department's efforts in traffic safety initiatives and the sixth year in a row to receive the association's "Community Traffic Safety Platinum" award.
- And, in December the department underwent a thorough and intensive, but very successful on-site assessment by the Commission on Accreditation for Law Enforcement Agencies (CALEA), setting up the department to obtain its third law enforcement accreditation and its first communications accreditation in early 2020.

I am extremely proud of both our accomplishments and the trusting relationships that we have forged and continue to strengthen with the citizens and visitors of Andover. I am even more proud of the professional men and women of this organization who have once again met the year's challenges with compassion, integrity and commitment!

Chief of Police

Chief "Mike" Keller was appointed as Police Chief of the Andover, Kansas Police Department on May 14, 2007, after serving 5-years as the Chief of Police in Wellington, Kansas. Prior to Wellington, Chief Keller spent 21 years with the Wichita Police Department, where he earned the rank of Lieutenant and commanded a number of sections including Traffic, Patrol, Training, Community Policing and Community Affairs. Chief Keller has been awarded three Bronze wreaths of Valor and Two Bronze Wreaths of Merit for acts of dedication and bravery.

Chief Keller is a graduate of the 222nd Session of the FBI's National Academy, the 2004 Kansas Police Administrator School, Leadership Butler (Class of 2009), and the 2010 Rural Executive Management Institute. Chief Keller is an Ethics and Diversity instructor and currently serves on the Butler Community College's Criminal Justice Advisory Board. Chief Keller is heavily involved in the community, serving as an Advisory Board Member for the Andover Police & Fire Foundation, a member of the Andover Rotary Club, a Paul Harris Fellow, and a member of the national Fight Crime: Invest in Kids program. In October of 2009, Chief Keller was appointed by Governor Mark Parkinson to serve on the Kansas Commission on Peace Officers' Standards and Training (KSCPOST) and re-appointed to the commission in 2012 by Governor Sam Brownback where he served until July of 2016. Additionally, Chief Keller has been an active IACP and KACP member for 18 years, serving as the Association's treasurer from 2007-2010, Vice President in 2010-2011 & 2017-2018, and President in 2011-2012 & 2018-2019. Additionally, Chief Keller was appointed and currently serves as the Kansas association's national SACOP

representative.

Chief Keller holds a Master Degree in Administration of Justice with an emphasis in Education from Wichita State University, and a Bachelor's Degree in Administration of Justice from Wichita State University. He is a veteran of the United States Air Force and a native of Utica, New York.

Chief Keller was the recipient of the 2015 "Officer of the Year" award.



Joseph A. Schroeder

Operations Commander

Captain Joe Schroeder started his law enforcement career with the Wichita Police Department in 1989 and served for almost 28 ½ years. During his career in Wichita, Joe served as a Police Officer, a Detective in Burglary, Financial Crimes, Auto Thefts, and was one of the first Detectives to serve in the Gang Crime Unit. He served as a Sergeant working initially as a Field Supervisor, and then in the Professional Standards Bureau (Internal Affairs). Joe was promoted to Lieutenant in 2005 and served as a Patrol Watch Commander, Recruit Training Instructor Section Commander in Investigations, Accident Follow Up (Traffic), Robbery, Financial Crimes, and Burglary. He also oversaw the department's Homeland Security efforts and City Facilities Security, and finished his career as the Commander of the Animal Services Bureau at the Wichita Animal Shelter.

In addition to his Law Enforcement service, Capt. Schroeder served 28 years in the military. He served in the Air Force and the Kansas Air National Guard where he retired in 2018 as the Superintendent of the 184th Regional Support Group at the rank of Chief Master Sergeant (E9). He has held positions in the Air Force as a Firefighter/EMT in Crash and Fire Rescue, Aerospace Propulsion Specialist, Security Forces, and Command and Control Battle Management Specialist.

Capt. Schroeder initially began his career with the Andover Police Department on July 3rd, 2017 as the department's first civilian Accreditation Manager, and then on October 8th, 2017 was promoted to and currently serves as the department's Operations Commander. As the Operations Commander, he oversees the day-to-day operations of both the Patrol

and Investigations sections. His additional duties include the Department's Use of Force Report Manager, Police Vehicle Pursuit Manager, Early Warning System Administrator, Victim/Witness Assistance Administrator, Juvenile Enforcement & Prevention Manager, Extra Duty Employment Coordinator, as well as, a member of the department's Accident Review Committee and Training Committee.

Capt. Schroeder has a Bachelor's Degree in Business Administration from Southwestern College in Winfield, Kansas and has graduated from the US Air Force NCO Academy, Senior NCO Academy, and the Chiefs' Executive Course. Captain Schroeder is also a 2016 graduate of the Kansas Police Administrators Seminar (KPAS)

Tracy "Buck" Buchanan *Special Services Commander*

Captain Tracy Buchanan began his career in law enforcement as an Andover Police Department Reserve Officer in 1994 and a few months later was hired by the Wichita (KS) police department. In 1997 Buck, as he is commonly known, returned to the Andover Police Department as a reserve Sergeant where he remained for 7-years. In 2004 Officer Buchanan was hired on as a full-time officer, and in 2005 moved to a Part-Time Officer position where he served until 2009. In August of 2009, Officer Buchanan returned to full-time status and assigned to the Patrol Division as a School Resource Officer. On April 1st, 2013, Buck was promoted to the rank of Sergeant and in August of 2013 reclassified to the rank of Lieutenant. On December 31st, 2017 Buck was promoted to Captain and currently serves as the Commander of the "Special Services" Division, where he directly supervises the department's four (4) School Resource Officers and the CALEA Accreditation Manager. As the Special Services Commander, Captain Buchanan also oversees the day-to-day operations for all community events and his extra duties include Recruitment & Pre-Employment Coordinator, Assistant Chaplain Program Coordinator, Defense Tactics Instructor, ASP Instructor, OC/Pepper Spray Instructor, Child Passenger Safety Seat Technician, serves on the Department's Accident Review Committee, Training Committee and chairperson of the Awards Committee.



Capt. Buchanan is a 2013 graduate of the Kansas University Public Management Center's "Command School," a 2016 graduate of the Kansas Police Administrators Seminar (KPAS) and a 2017 graduate of the 270th Session of the FBI's National Academy.

Director Becky Tapia, began her career in Public Safety in 2002 with Winfield Area Emergency Services as an Emergency Medical Technician, and served as a Reserve EMT/ Fire Fighter with the Winfield Fire Department. In 2007, Director Tapia began working as a full-time Dispatcher for the Winfield Police Department in Winfield Kansas, earning the rank of Senior Dispatcher. In 2013, Director Tapia was promoted to Communications Shift Supervisor for Cowley County Emergency Communications. 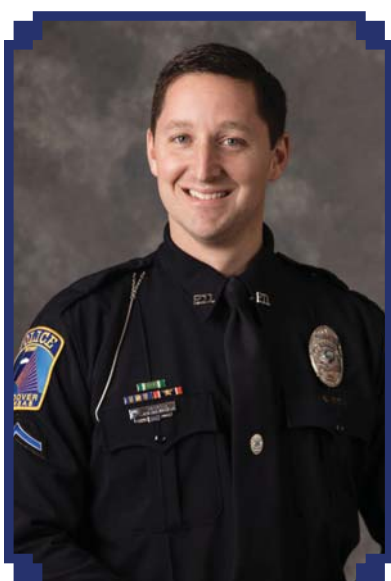
Michael J. Sine

Thor Tribute



On Saturday, August 17th, the Police Department was very saddened to report, that following a brief illness, our oldest and finest K-9 "Thor" passed away. "Thor" would have been 10-years old in September, and was scheduled to retire in just a few weeks.

"Thor" was a male Belgian Malinois, born on September 16, 2009 in The Netherlands, and was purchased on April 25, 2011 through the Hill Country Dog Center in Pipe Creek, Texas, possibly with a donation by the Capital Federal Bank in Andover. "Thor" was actually a "Blue" Belgian, which refers to the color of his coat, which is considered rare for this breed. "Thor" began his official training through the Sedgwick County Sheriff's Office in April of 2011 and successfully completed the 10-week Patrol Dog and Drug Search School with then Officer Mickey Farris in July of 2011. "Thor" was a dual purpose K-9 trained and certified through the Kansas Police Dog Association (KPDa) in both drug detection including Marijuana, Heroin, Methamphetamine and Cocaine, as well as, Patrol Tactics which included building and evidence searching. He had many successful searches during his 8+ year career. "Thor" was also certified in Tracking and Trailing, and loved to go to the schools and community events to perform demonstrations.

"Thor" was a phenomenal dog, and I truly believe that he was one of the finest Police K-9's in the State, both for Drug Work and Police Work," said Chief Mike Keller. With the passing of "Thor", Officers of the Andover Police Department wore the black band of mourning through 12:00 midnight on Saturday, August 24th, 2019.

On Saturday, September 28th, as a part of Greater Andover Days, the Police Department hosted a memorial service for our K-9 "Thor," with over one-hundred Andover residents in attendance. The service was more of a tribute or celebration of "Thor's" life and his service to the Andover Community. The tribute was held at the Capitol Federal Amphitheater with approximately 100 people in attendance, as well as K-9 teams from six other agencies. The tribute, which lasted approximately 20-minutes included an introduction, invocation, eulogy, flag presentation, taps, and a gift to Sgt. Farris from Heritage Funeral Home.

2019 Highlights



The Andover Police Department initially received CALEA's "Advanced Law Enforcement Accreditation" on March 23, 2013, having demonstrated compliance with a comprehensive set of over 360 standards that reflect policing's "best practices." This coveted designation is considered the highest standard of excellence in law enforcement. Only 5% of all law enforcement agencies in the entire country are Nationally Accredited, and the Andover Police Department ranks very high among those agencies.

In December of 2015, the agency went through their second on-site, 4-day assessment, demonstrating its continued compliance with these CALEA standards. Saturday morning, April 2nd, 2016 Chief Keller, along with the department's accreditation manager Lt. Buck Buchanan, Investigations Commander Captain Justin Phillips, Communications Director Becky Tapia and Andover City Administrator Mark Detter appeared before CALEA's full board of commissioners to answer questions. At the conclusion of the hearing, the board of commissioners unanimously approved the Andover Police Department's request for re-accreditation and awarded CALEA's "Advanced Law Enforcement Accreditation."

In very early 2018 the Police Department's E-911 Emergency Communications Center entered into the self-assessment phase in pursuit of Communications Accreditation. The self-assessment phase of accreditation for a Communications Center generally takes approximately 2-years to complete in preparation for accreditation.

On Friday, March 22nd through Saturday, March 30th, 2019 the Police Department underwent an "Annual Compliance Review" for CALEA Law Enforcement accreditation. This is an annual review of approximately one-quarter of the department's files and standards, conducted remotely by a Compliance Service Member. On Friday, March 29th Chief Mike Keller received notification from Judi King, the Compliance Service Member, advising that the department's Annual Compliance Review was complete, and "Overall, the department did an outstanding job of file preparation and proofing. I was able to confirm compliance with all standards that were reviewed."

On Tuesday, May 7th through Friday, May 10th, the Police Department hosted a "Mock Assessment" of the department's compliance with CALEA standards. Christi Asbe, accreditation manager from the Kansas Highway Patrol (KHP) and Bobbie Hawkins from the Ottawa Police Department were our onsite assessors, along with Heather Durham from the Oklahoma City Police Department and Sheila Setzer from the Parker Colorado Police Department who were assessing remotely through a web-based format. Asbe, Hawkins and Durham reviewed all files on the Law Enforcement side of accreditation while Setzer reviewed files for the Emergency Communications Center. This "Mock Assessment" was necessary to help prepare the Police Department for the department's third official CALEA Onsite 4-year Law Enforcement Assessment and the E-911 Communication Center's initial Communications Accreditation assessment, scheduled for mid-December.

On Monday, December 9th through Thursday, December 12th, the Police Department underwent an on-site assessment for its third law enforcement accreditation and an initial accreditation for our E-911 Emergency Communications Center. Chief John Bruce (Richland, WA) and Lieutenant Paul Malech (Oakland, CA) spent 4-days observing officers and dispatchers in their daily activities, talking with residents, elected officials and partner organizations, and reviewing the department's performance against CALEA standards. I am extremely proud to announce that the department experienced a phenomenal on-site review with zero problem areas noted. The assessors, Chief Bruce and Lt. Malech, on their final day during the exit debriefing advised that our department was a step above most CALEA accredited agencies, and that they were both impressed with the professionalism and commitment of our staff to the CALEA process. Chief Bruce advised that this was one of the best on-site assessment that he has ever been involved in!

In March of 2020, members of the Andover Police Department and E-911 Emergency Communications Center will travel to Orlando, Florida to attend the CALEA Spring Conference. The Department fully expects to receive its third CALEA Law Enforcement accreditation, and its first CALEA Communications accreditation. Upon receipt of the Communications accreditation, the Andover E-911 Emergency Communications Center will be the first Communications Center in Kansas to become accredited.

The Law Enforcement Accreditation Program was the first credentialing program established by CALEA after its founding. It was originally developed to address what was seen as a need to enhance law enforcement as a profession and to improve law enforcement service delivery. That mission continues today through a tiered law enforcement accreditation program. Agencies may participate in either CALEA Law Enforcement Accreditation (Tier 1) or CALEA Advanced Law Enforcement Accreditation (Tier 2), without regard to agency size.

2019 Highlights



Since the first CALEA Accreditation Award was granted in 1984, the program has become the primary method for an agency to voluntarily demonstrate their commitment to excellence in law enforcement. The standards upon which the Law Enforcement Accreditation Program is based, reflect the current thinking and experience of law enforcement practitioners and researchers. Major law enforcement associations, leading educational and training institutions, governmental agencies, as well as law enforcement executives internationally, acknowledge CALEA's Standards for Law Enforcement Agencies® and its Accreditation Programs as benchmarks for professional law enforcement agencies.

- CALEA Accreditation requires an agency to develop a comprehensive, well thought out, uniform set of written directives. This is one of the most successful methods for reaching administrative and operational goals, while also providing direction to personnel.
- CALEA Accreditation standards provide the necessary reports and analyses a CEO needs to make fact-based, informed management decisions.
- CALEA Accreditation requires a preparedness program be put in place—so an agency is ready to address natural or man-made unusual occurrences.
- CALEA Accreditation is a means for developing or improving upon an agency's relationship with the community.
- CALEA Accreditation strengthens an agency's accountability, both within the agency and the community, through a continuum of standards that clearly define authority, performance, and responsibilities.
- Being CALEA Accredited can limit an agency's liability and risk exposure because it demonstrates that internationally recognized standards for law enforcement have been met, as verified by a team of independent outside CALEA-trained assessors.
- CALEA Accreditation facilitates an agency's pursuit of professional excellence.

Donuts With The Chief

On Thursday, January 3rd, Chief Mike Keller addressed a group of approximately 24 residents at the monthly "Donuts with the Chief" hosted by the Andover Senior Center. During the meeting, Chief Keller gave a year-end wrap up for 2018, including a few statistics, an overview on a couple of recent cases/investigations and talked about expectations for 2019.

On Thursday, March 7th, Chief Mike Keller and Asst. Fire Chief Mike Roosevelt attended the monthly "Donuts with the Chief" event hosted by the Andover Senior Center. Approximately 30 plus residents were in attendance to hear about what's been happening in the police department over the last 2-months (February's Donut's with the Chief was cancelled due to a snow storm). The Chief spoke about the department's annual awards, a couple of recent investigations, an update on the Yorktown road project, the legalized marijuana senate bill currently in Topeka, and the Police Department's upcoming "Storm Fury on the Plains" public presentation. Near the conclusion of the presentation, Chief Keller and Asst. Fire Chief Roosevelt were both presented with hand-made quilts made by Pat Huck for each of their departments.



On Thursday, April 4th, Chief Mike Keller and Det. Natasha Ward met with approximately 20 residents at the monthly "Donuts with the Chief" at the Andover Senior Center. On Thursday, October 3rd, Chief Mike Keller attended the monthly "Donuts with the Chief" event, sponsored by "Dunkin Donuts" and hosted by the Andover Public Library. Approximately 10 people attended to hear the Chief talk about an overview of "Greater Andover Days," the "Thor" Memorial Service, and recent criminal investigations in the Andover area.

On Thursday, November 7th, Chief Mike Keller attended the monthly "Donuts with the Chief" at the Andover Senior Center, after a 2-month relocation to the Andover Public Library. Chief Keller spoke to the group of approximately 30 residents about the Police Department's activities over the past 30+ days, including traffic enforcement efforts, investigations and community events such as the Fill-A-Cruiser, Drug Take Back Event and Safe Halloween.

On Thursday, December 5th, Chief Mike Keller attended the monthly Donut's with the Chief at the Andover Senior Center where Chief Keller addressed a group of approximately 27 citizens and spoke about recent crime incidents, the department's CALEA accreditation process including the upcoming on-site assessment, and the department partnering with Andover's "Caring & Sharing" program and Children's Home for Christmas.

Traffic Safety Committee

On Wednesday, January 23rd, the department's "Traffic Safety Committee," coordinated by Lt. Lance Parker held their first meeting of 2019. The "Traffic Safety Committee" is comprised of representatives from the City Council, City Administration, Public Works, Police Department, School District and Community, and tasked with meeting three times a year to review the Motor Vehicle accidents, Traffic Complaints and the department Traffic Enforcement efforts. Representatives from Butler Community College have been invited to join the committee and will be in attendance at the next meeting in May.

On Wednesday, May 22nd, the Police Department hosted a quarterly Traffic Safety Committee meeting. In attendance were Council Member Caroline Hale, Rick Lanzrath, Bill Braitsch, Steve Anderson, Bill Rinkenbaugh (Vice President of Student Services, Butler Community College), Captain Joseph Schroeder, Chief Mike Keller, and Committee Coordinator Lt. Lance Parker. The group reviewed and discussed the previous 4-months of traffic accidents, traffic related complaints, traffic

enforcement efforts, and received an update on the department's "School Bus Stop Arm Initiative."

On Wednesday, September 25th, the Police Department hosted the third "Traffic Safety Committee" meeting of 2019. The meeting, coordinated by the Department's Traffic Safety Coordinator, Lt. Ben Graber, covered the Police Department's traffic enforcement efforts, traffic accidents and traffic complaints over the past 4-months, as well as several traffic problem areas such as Harry and Andover Road, Minneha and Andover High School traffic with the construction. In attendance were Lt. Ben Graber, Captain Joseph Schroeder, SRO Heath Kintzel, City Council Member Caroline Hale, Poe & Associates Mike Thompson, City Engineer Steve Anderson, Street Department Superintendent Bill Braitsch, BCC Vice President Bill Rinkenbaugh and BCC Police Chief Jake Kenney.

Search For A New K-9

On Sunday, February 3rd, Sgt. Mickey Farris and MPO DeShaun Smith left for the "Hill Country Dog Center" in Pipe Creek, TX (near San Antonio) to search for a new K-9. This new K-9 will be partnered with MPO Smith and will replace "Thor" who is scheduled to retire later this year. Over the next day or two, Sgt. Farris and MPO Smith will be testing a number of perspective K-9 to find one for Andover. The "Hill Country Dog Center" is the same Kennels that "Hondo" was purchased from in 2009 and "Thor" was purchased from in 2011.



On Tuesday, February 5th, Sgt. Mickey Farris, along with MPO DeShaun Smith and his new K-9 partner left the San Antonio area headed for home. The Police Department's newest K-9 member, to be named later, is a 17-month old male German Shepherd from Holland. A "meet and greet" for the community will be scheduled in the very near future. MPO Smith and his K-9 partner will immediately begin working on obedience type training, and later this year will go through formal police K-9, drug and search training with the Sedgwick County Sheriff's Office and Wichita Police Department. This new K-9 was made possible and funded by the Andover Police & Fire Foundation (AP&FF).



On Wednesday, February 6th, the Department's newest K-9 member, a 17-month old German Shepherd from Holland was checked out by our local K-9 Vet, Dr. Ron Kutter and was determined to be in good condition. A community introduction will be scheduled in the very near future. MPO Deshaun Smith and his K-9 partner will go through formal police K-9, drug and search training with the Sedgwick County Sheriff's Office and Wichita Police Department in the early spring. This new K-9 was made possible and funded by the Andover Police & Fire Foundation (AP&FF).

On Thursday, February 28th, the Andover Police & Fire Foundation (AP&FF) and the Police Department introduced the department's newest K-9, "Roko" and his handler, MPO Deshaun Smith to the public.

On Sunday, March 17th, MPO Deshaun Smith and his K-9 partner "Roko" headed for Hill Country Dog Center in Pipe Creek, Texas to drop "Roko" off and he will go through the next 5-weeks of obedience, narcotic scent detection (except marijuana), tracking and bite training. On April 22nd, MPO Smith will re-join "Roko" where they will together go through an additional 4-weeks of training. MPO Smith and "Roko" are expected to return to Andover around May 17th, 2019 fully trained and ready for certification through the Kansas Police Dog Association.

On Sunday, April 21st, MPO Deshaun Smith headed to the Hill Country Dog Center in Pipe Creek, TX to meet up with K-9 "Roko" and participate in four-weeks of "Canine Handler" training and their initial Certification.

On Saturday, May 18th, MPO Deshaun Smith and K-9 partner "Roko" returned home after spending the past 4-weeks in training and graduating from the Hill Country Dog Center's K-9 School in Pipe Creek, TX, and is now certified in Patrol work and Narcotic Detection.



City Employee Appreciation Dinner

On Saturday evening, January 19th at the Andover City Employee Appreciation dinner, Lt. Ben Graber, Sgt. Troy Snedeker and Master Communications Officer Eric Wesbrooks were both recognized for their 10-years of dedicated and loyal service to the Andover community. Additionally, Det. Natasha Ward and MPO Michael Sine were both recognized for their 5-years of dedicated and loyal service to Andover. Our department would not be the same without all of you!



Domestic Battery

On Sunday, January 20th at approximately 12:30 a.m. in the morning officers responded to a Domestic Disturbance in the 200 block of West 1st Street. Upon arrival officers found that two cousins who were living at the residence had apparently gotten into a physical altercation and one of the suspects had left the residence prior to the officers' arrival. The officers also learned that the remaining suspect had armed himself with a handgun and discharged the weapon in the yard and inside the residence prior to officers arriving. Officers made contact with the armed suspect, who immediately surrendered the handgun, but while attempting to take him into custody, he refused to cooperate, threatened to go get another weapon and attempted to leave. The suspect was TAZED and taken into custody without further incident. Matthew J. Debita, 33-year old white male was booked into Butler County Jail of for one count each of Domestic Battery and Unlawful Discharge of a Firearm. The second individual, Michael A. Debita, 27-year old white male was also located and booked into the Butler County Jail on one count of Domestic Battery.

Aggravated Domestic Battery

On Monday, January 21st, in the early morning hours, a 17-year old Andover resident in the 200 block of Koob Lane reported being in a physical altercation with her live-in boyfriend and the father of her 16-day old child. The victim had been punched, head-butted and choked by the boyfriend. Once the suspect fell asleep, the victim was able to flee the residence and went to her parent's home in Wichita where she called the Police. Officers located the suspect later that morning at the home on Koob Lane and brought him to the station for questioning. Jorge L. Vasquez, a 25-year old Hispanic male was booked into the Butler County Jail for Aggravated Domestic Battery. Potential additional charges pending.

False Robbery Report Results in Drug Arrest

On Monday, February 1st, Officers were dispatched to a report of an aggravated robbery in the area of 700 S. Ruth. Upon arrival officers made contact with two females, Meagan Sicka of Goddard and Tanya Newberry of Cheney, who claimed they were both robbed at gunpoint by two males. One of the males was immediately identified as Christopher Tilley of Andover and found to be hiding in an RV behind his residence along with a female who identified herself as Misty Deere of Wichita. An investigation revealed that a robbery did not actually occur. Sicka and Newberry later admitted that Tilley took their money during a drug deal, and did not give them the methamphetamine they paid for. A search warrant was executed on the RV and methamphetamine and paraphernalia was found. Both Sicka and Newberry were charged with conspiracy to possess methamphetamine, and interference with a law enforcement officer for their false report. Tilley was charged with possession of methamphetamine, possession of drug paraphernalia and theft. Misty Deere was found to have given a false name and was identified as Kathy Deere who had a \$25,000.00 dollar warrant through Sedgwick County. Deere was also charged with identity theft and interference with a law enforcement officer. All four individuals were booked into the Butler County Jail.

Library Protest

On Wednesday, February 13th, members of the Westboro Baptist Church (WBC) arrived in Andover to protest the Andover Public Library's board meeting in which a controversial children's book was going to be discussed and voted on. The group of five (5) protesters staged in Central Park across from the library and protested from approximately 5:00 p.m. until 5:40 p.m. Following the WBC protest, three officers stayed in the library to assist library staff with any issues that may have occurred during their board meeting. Fortunately, there were no issues or counter protests at either event.



2018 Officer & Civilian of The Year Presentation

On Tuesday, February 26th at the City Council meeting, MPO III Tiah Smith received the "Officer of the Year" award and Records and Evidence Custodian Kelli Galloway received the "Civilian of the Year" award, for their efforts, actions and successes in 2018. Captain Buck Buchanan also received a "Community Service" award for all of his efforts in 2018 organizing and coordinating the security efforts for the city's five concerts, Greater Andover Days and the week-long National Fireworks demonstration. Drug Investigation/Search Warrant

On Wednesday, February 27th, following a month-long Andover undercover drug investigation with assistance from the El Dorado Police Department, Butler County Sheriff's Office and the Kansas Bureau of Investigation, a search warrant was drawn and executed at a residence in the 200 block of West Harry. At approximately 2:10 p.m. the Butler County Sheriff Department's SWAT team breached the residence of a Nichol Smith, 216 W. Harry and placed Ms. Smith along with two other local residents into custody. Once the home was secured, Andover Detectives conducted a search and recovered evidence indicating the possession and sale of narcotics. Ms. Smith was interviewed and booked into the Butler County Jail on charges of possession of methamphetamine, unlawful sale of a controlled substance and possession of drug paraphernalia. The male located in the residence was turned over to the Augusta Department of Public Safety on an outstanding warrant. The other female found in the home was released without charges. Additionally, Andover Code Enforcement was called to the scene of the home and based on obvious violations, the home was immediately condemned, temporarily preventing any inhabitation.

Meadowlark Elementary School

On Friday, March 1st, students and staff from Meadowlark Elementary School stopped by the Police station to drop off two 5 Gallon buckets full of treats and water for members of the department. We are so blessed to have such a supportive community. Thank you Meadowlark Elementary!



E-Cigs Result in Burglary Arrest

On Monday March 18th, a parent came to the Andover Police Department to turn in numerous bottles of e-cig fluid (juice) that she found in her 15 year old son's room. Officers interviewed the 15 year old male at Andover Central High School where he disclosed that he had snuck out of his residence earlier that morning (around 2:00 a.m.), and while walking around town he found an unlocked door at McVapour E-Cigs and Novelties, 340 S. Andover Rd., advising that he entered the business and stole the items his mother had brought into the station. Juvenile Intake and Assessment was notified and the juvenile, who has had prior law enforcement contact was placed into a secure custody facility in Reno County pending court proceedings.

DUI/Drug Arrest

On March 21st, Officers responded to 100 E. Hwy 54 for a report of an individual passed out in his car near the intersection of Highway 54 and Andover Road. Officers made contact with Paul Kilgore, 29-year-old male of rural El Dorado at the scene. After being checked by EMS and refusing any treatment, officers put Mr. Kilgore through a Standardized Field Sobriety Test in which he failed and was arrested for Driving Under the Influence. Upon a search of his vehicle and person, officers discovered 5 grams of methamphetamine and 6 grams of marijuana along with other drug paraphernalia. Mr. Kilgore was booked into the Butler County Jail for Possession of a Stimulant Drug, Possession of Marijuana, Possession of Drug Paraphernalia and Driving Under the Influence (drugs).

Police Department Hosts Chamber Meeting

On Thursday, March 28th, Det. Natasha Ward attended the monthly Chamber meeting, hosted in the basement training room of the police department. It was a full room and representatives from city, fire, and police were present. City staff spoke briefly about continued work on the Yorktown development. Fire spoke of grass fire warnings, and Det. Ward talked about an up-coming community training to be hosted by the Police Department's Investigation's section.

Aggravated Domestic Violence Arrest

On Thursday March 28, 2019 at around 1000 hours officers were dispatched to Cloud Ridge Apartments to investigate a domestic battery that took place the night before in the 500 Block of N. Boylan Street. The victim, a 30 year old female Andover resident reported that she had been beaten, choked to the point of losing consciousness, and sexually assaulted by her boyfriend, who at one point, held a knife to her throat. The victim stated that the suspect, Joe Dale Volkman Jr., a 29 year old male from Augusta, was a heavy drug user and had been smoking methamphetamine the entire day leading up

to the incident. Investigators and patrol personnel went to the residence where the incident reportedly took place and made entry into the residence where the suspect was located. Volkman was taken into custody and after an interview was booked into the Butler County Jail on numerous felony charges to include Rape, Criminal sodomy, Aggravated Domestic battery, Possession of Methamphetamine, Criminal Possession of a Weapon by a Felon, Criminal restraint, Possession of Marijuana, Possession of Drug Paraphernalia, Aggravated Assault with a Deadly Weapon, and Aggravated Endangering of a Child.

2019 Storm Fury on The Plains

On Thursday, March 28th, the Police Department hosted the public presentation "2019 Storm Fury on the Plains," presented by Butler County Emergency Management. Approximately 18 citizens attended the presentation about how storms develop, how to identify threatening weather and what to do if you come face-to-face with a hazardous situation.

Police Department Golf Cart

On Thursday, March 28th the Police Department took possession of the newest member to its fleet of vehicles, a 2013 Club Precedent Gas Powered 4-seater Golf Cart. The vehicle was purchased through M&M Golf Cars in Andover, painted and seats recovered courtesy of Andover Collision at no cost, and an emergency light-bar was installed by Superior Emergency Response Vehicles (another Andover business). The vehicle will be used as an additional resource to the department's Kawasaki Mule at all concerts, Police & Fire Festivals, Greater Andover Days and other special events.



National Wear Blue Day

On March 28th, Det. Natasha Ward put out signage and blue pinwheels in front of the police department in a cooperative effort with the "Sunlight Child Advocacy Center (CAC) to support "Child Abuse Prevention Month." The blue pinwheels are a part of Pinwheels for Prevention and staff members will be encouraged to wear blue on April 5th in support of "National Wear Blue Day" to help promote Child Abuse Prevention.



Commercial Burglary Arrest

Over the course of thirteen days the City of Andover experienced three commercial burglaries that were similar in nature and method of operation (MO), a tanning salon, a heating and air conditioning business and a firearms store. On Sunday, April 7th, very near midnight Officer Tiah Smith, while on routine patrol stopped and identified an individual, a Frederic A. Doffing from Wichita, who was supposedly out for a walk. Early the next morning it was discovered that the tanning salon had been burglarized. Lt. Daimon Cundiff while working the burglary learned about the suspicious individual that Officer Smith had stopped the evening before and after a criminal records check disclosed previous burglaries, Mr. Doffing became a probable suspect. Additional investigation revealed that Mr. Doffing had a girlfriend in Eureka, and that the Greenwood County Sheriff's department were very familiar with both Mr. Doffing and his girlfriend. Following an arrest of Mr. Doffing later that afternoon who was in possession of three stolen guns, a search warrant was drawn and executed on the girlfriend's house in Eureka where property from two of the three Andover businesses was located and recovered. Mr. Doffing remains in the Greenwood County Jail on local charges and a hold awaiting charges in Butler County. Mr. Doffing has also been implicated in additional commercial burglaries in El Dorado, Augusta, Derby, and Haysville.

Andover 5th Safest City in Kansas

On Tuesday, April 9th, "Safewise" an independent review site regarding Home Security, released their "Safest Cities in Kansas" report for 2019, and Andover ranked number #11. In January, the National Council for Home Safety and Security published a similar study, ranking Andover 5th for the safest cities in Kansas, with a population of at least 10,000. Safewise incorporated all cities that reported crime in Kansas in their study, including cities like Beloit with a population of 3,761. In fact, 8 of the 10 cities in Kansas ahead of Andover on the list have a population less than half that of Andover. The top 20 cities, in order, included: Hesston, Rose Hill, Fairway, Basehor, Leawood, Abilene, Mulvane, Louisburg, Derby, Beloit, Andover, Colby, Valley Center, Osawatomie, Bel Aire, Lenexa, Goddard, Maize, Shawnee and Olathe.

The study compared Violent Crime and Property Crime, demonstrating that Andover's Violent Crime and Property Crime rates were significantly below the National and Kansas numbers. The national rate for Violent Crime is 4.49 incidents per 1,000 people, and the Kansas rate is 4.75, while Andover experienced 1.37 violent crimes per 1,000 residents. Additionally, the national rate for Property Crimes is 27.11 incidents per 1,000 people, and the Kansas rate is 32.57, while Andover experienced 7.89 property crimes per 1,000 residents.



National Public Safety Telecommunications Week

On Tuesday, April 9th, Mayor signed a proclamation declaring the week of April 14th through April 20th as National Public Safety Telecommunications' Week." Several Communications staff members were in attendance for the signing of the proclamation.



Drug Arrest Vehicle Stop

On Thursday, April 25th, Officer Annie McCully stopped a vehicle suspected in a hit & run in Wichita, and as the driver exited the vehicle she observed a syringe sticking out of the driver's pocket. A subsequent search found the driver to be in possession of 17 grams of cocaine and 14 grams of methamphetamine. A search of the individual's vehicle, incident to the arrest, resulted in the finding and seizure of a loaded .40 caliber semi-auto handgun, a sawed off shotgun, \$698 in cash and additional drug paraphernalia. James S. Cole, 48-year old out of Wichita was arrested and booked into the Butler County Jail on charges including "Possession of a Controlled Substance," "Possession with the Intent to Distribute" and "Possession of a Firearm by a Felon."

K-9 Sniff - Drug Arrest

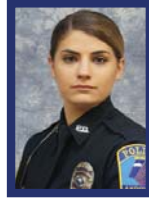

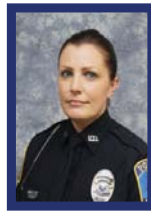


Police Memorial Banquet

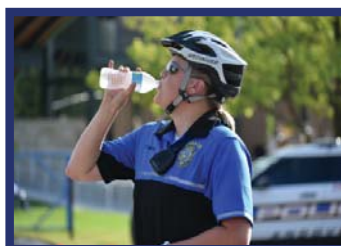
Law Enforcement Torch Run

The incident scene was processed by detectives, and individuals present interviewed. It was determined that the 18-year old male was playing with what he thought was an unloaded gun when it went off, striking the young lady in the lower leg. The 15-year old female, who was in good condition, was later transferred to Wesley hospital for further treatment. The case, currently still under investigation, will be sent up to the Butler County Attorney's office for consideration.

Police Department Hosts Chamber Lunch & Learn

On Tuesday, June 18th, the Investigations Section, in partnership with the Andover Area Chamber of Commerce, hosted a luncheon/training for local business owners on "Scams and recent trends in Criminal Activity." Detective Michael Shinert and Lt. Daimon Cundiff gave the presentation to approximately ten local business owners. Special attention was given to the fact that almost all vehicle burglaries occur from unlocked vehicles.

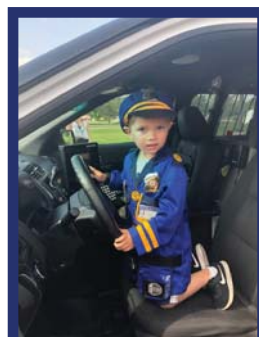

Murder Charge Conviction - Sentenced to 186 Months

On Friday, May 25th, 2018, following an almost 2-year investigation by Detective Natasha Ward, charges were formally filled on Roger Smith for one count of Murder in the 2nd Degree in the domestic violence related death of Sandra "Sandy" Berry. On Friday, April 19th, 2019 Roger Smith plead guilty to the lesser charge of voluntary manslaughter as a part of a plea agreement and admitted in open court to intentionally killing Sandra Berry. On Thursday, June 20th, Roger Smith appeared in court represented by his lawyer Steven Waggle for his sentence hearing. At the beginning of the hearing, Judge Jan Satterfield first denied a motion that Roger Smith had filed in an attempt to vacate his original guilty plea, and then after listening to comments from Ms. Berry's brother who spoke for the family, Judge Satterfield sentenced Mr. Smith to 186 months, which was a part of the original plea agreement. Judge Satterfield also order that Mr. Smith reimburse the Kansas Victim's Crime Fund \$5,000, which was the apparent cost of Ms. Berry's funeral.

Andover Public Library's "Hero's Breakfast"

On Friday, June 21st, members of the Andover Police Department, along with representatives from the Wichita Police Department's Mounted Unit and the Andover Fire Rescue attended the Andover Public Library's annual "Hero's Breakfast" where the officers had the opportunity to spend some quality time with some of our younger community members. Approximately 95 children and 70+ adults were present for the morning's activities.

On Friday, June 21st, Captain Buck Buchanan and Chief Mike Keller grilled burgers and hotdogs for the Andover Chamber of Commerce's first Annual Corn Hole Tournament. Troy Snedeker and Administrative Assistant Becky Page also represented the Police Department and participated in the Corn Hole Tournament. A great time was had by all!



Car Burglars Arrested

On Saturday, June 22nd, at approximately 2:30 a.m. Officers were dispatched to a "suspicious character" call in the 100 block of E. Douglas where a citizen reported that her dog was barking and when she looked outside she observed four males jumping into a White Dodge Ram pick-up truck and leaving the area. Off. Joseph Hardy, the first officer in the area located the vehicle and stopped it a few minutes later in the area of Douglas and Shay. Four subjects were detained and several items of stolen property were recovered inside the bed of the pick up. During the subsequent interviews, the suspects admitted to what they referred to as "car hopping" where they entered approximately 20 unlocked vehicles in Andover earlier that evening and committed various thefts from a number of them. There were three juvenile suspects (17 years old) who were all released to their parents by the Juvenile Intake and Assessment Center (JIAC), and one adult, Dimitri Fernandez 18 H/M from Wichita who was booked into Butler County Jail for Burglary and Theft charges. All four suspects will be charged.

Serious Motor Vehicle Accident

On Saturday, June 29th, at approximately 8:00 pm, officers and Kansas Highway Patrol were dispatched to a one-vehicle injury accident on the I-35 turnpike near the 159th Street Bridge. After arrival, they discovered that the vehicle actually had been driving north on 159th, left the roadway just south of the KTA bridge, went airborne, and landed on the Turnpike. The driver of the vehicle, a 21 year old male from Andover, was taken to Wesley Hospital in very serious condition. As of July 1st, the driver was still in critical, but stable condition. KHP Troopers worked the accident with Andover officers assisting.

Red Dirt Roundup Festival Concert

On Saturday, June 29th, the Police Department provided security for the Red Dirt Roundup Festival Concert with the crowd estimated to be around 1,300 citizens. A very hot night, but the evening was very quiet, no issues, problems or arrests with the exception of a parking lot hit and run vehicle accident. A good time was had by everyone in attendance.

Additional Car Burglars Arrested

On June 7th, during the overnight hours, numerous unlocked vehicles were burglarized in the Andover neighborhoods along 159th. An assortment of property was stolen from the unlocked vehicles, including two unsecured handguns, and one motor vehicle was also reported stolen. On June 9th, the stolen vehicle was stopped by the Kansas Highway Patrol in Wichita. During a search of that vehicle, a receipt was found for a gun light that had been purchased earlier that day from Academy Sports. Video of the transaction was obtained from the business by detectives and it was determined that the individual who purchased the light, a 17 year old Wichita resident, was known by our detectives to have been involved in an aggravated robbery last summer in Andover. On the video it was also discovered that the individual was wearing an ankle GPS monitoring device from the previous Andover case. The GPS tracking data was obtained for that ankle monitor, and along with a couple of interviews, it was determined that this individual along with the other males involved in the aggravated robbery case last year were responsible for six reported vehicle burglaries and the theft of the vehicle in Andover. It was also determined that that these three were responsible for five additional vehicle burglaries in Wichita, in which two additional firearms were stolen. Andover Detectives arrested all three individuals, the 17-year old juvenile, along with Jeremiah Dillard (18 year old Wichita resident) and Logan Basham (18 year old Wichita resident), and all three have been charged with six counts of vehicle burglary, two counts of theft of a firearm, and theft of a motor vehicle.

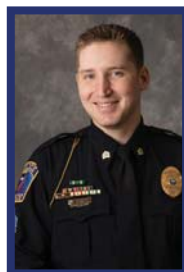
New Officer James Wilkinson

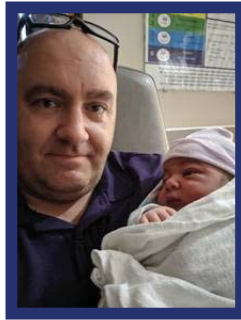

Auto Theft Arrest

On Wednesday, September 11th, in the early morning hours, a 2017 Ford Escape was reportedly stolen in the 300 Block of N. Lakeside (keys left in the vehicle). The victim relayed to officers that there was GPS monitoring installed in the vehicle and they were able to give the location of the vehicle as it traveled, eventually coming to a stop at the Target store located at 7575 W. Maple in Wichita. Lt. Daimon Cundiff and Detective Natasha Ward, in a coordinated effort with Wichita Police and Target Security, sat off the vehicle waiting for the driver and occupants to return. A short time later three suspects exited the store and unlocked the stolen vehicle using the key fob as they approached. All three suspects were taken into custody prior to making entry into the vehicle. The driver of the vehicle, a 26-year old white male from Manhattan, had a stolen handgun tucked in his waistband and 7 grams of methamphetamine in his possession at the time of his arrest. An 18-year old white male from Wichita was arrested and booked by Wichita on outstanding warrants to include two felonies. A 19-year old white female from Wichita was arrested and booked by Wichita for a shoplift that she committed while in the Target store. After Andover detectives interviewed the 26-year old driver, he was released to the Riley County Police Department as a suspect in over 20 burglary cases.

Annual Supervisory Retreat

Counterfeit Money Search Warrant

On Monday, September 23th, the Police Department took a report whereby counterfeit \$50 bills were taken in by three separate businesses in Andover. On Wednesday, September 25th Andover Dispatch received information that an individual just attempted to pass a counterfeit \$20 bill at another local business. Officers moved in immediately and apprehended the individual about a block away. The suspect, a 45-year old white male was taken to the Police Department where he admitted to the attempted passing of a \$20 bill, as well as, identified other individuals and a location just outside of Andover where the counterfeit bills were being produced. Detectives, in cooperation with the Butler County Sheriff's Office wrote and executed a search warrant for a residence in Butler County later that evening and recovered counterfeit manufacturing supplies and equipment, as well as a few counterfeit \$50 bills. Charges are pending against several individuals involved. Secret Service has been contacted and are considering additional federal charges.

Bulletproof Vest Partnership Grant Award

On Tuesday, September 24th, the Police Department was notified by the Bureau of Justice Assistance (BJA) that they have been selected to receive a grant award under the Fiscal Year (FY) 2019 Bulletproof Vest Partnership (BVP) program in the amount of \$2,290.59. This grant award is a reimbursement grant that will reimburse the department 50% of the cost of all bullet proof vest purchases between April 1, 2019 and August 31st, 2021.

Greater Andover Days (GAD)

On Thursday, September 26th, Friday, September 27th and Saturday, September 28th Greater Andover Days (GAD) went off with very few hick-ups! The Police Department once again participated in the parade with 2018 Officer of the Year Sgt. Tiah Smith towards the front of the parade, followed by Chief Keller. Accreditation Manager Jessica Smith was a huge hit with the crowd as "McGruff" escorted by Admin Asst. Becky Page, followed by MCO Eric Wesbrooks as "Red E. Fox" and escorted by Records Clerk Kelli Galloway. MPO Joel McLaughlin and his K-9 partner "Bandit" also excited the crowd in the parade, escorted by Communications Director Becky Tapia, and later performed a K-9 demonstration in Central Park. The Police Department also provided security and parking control throughout the event, including the Thursday night concert, Friday night "Tailgate Party," Saturday's parade and festival activities, and Saturday night's "Fireworks." All of this was accomplished once again with very few incidents. Other than the light rain that put a damper on the Saturday morning parade, we only had one incident, a very minor disturbance between a 12-year old and his mother on Saturday night. A chase ensued and went east on 254 and approximately 4 miles later, near KS-254 and Adams Road, the suspect wrecked his vehicle and fled on foot into a rural residential area. KHP requested their K9 and air support. MPO Joel McLaughlin and his K-9 partner "Bandit" were dispatched to the location to assist. Upon arrival MPO McLaughlin and "Bandit" began searching a hedge row on the east perimeter of the area when the suspect jumped from the hedgerow and began to run. MPO McLaughlin, after warning the suspect to stop, released K9 Bandit who caught the suspect by his arm and took him down, where he was taken into custody by approaching officers/deputies. The suspect was treated on scene for the dog bite and arrested for DV charges in relation to the original call and felony evade.

Spaulding's 3rd Annual .27k Walk

Child Pornography Search Warrant and Arrest

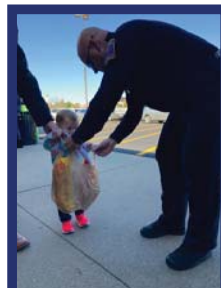
On Friday, October 11th, at approximately 7:25 am in the morning, the Andover Police Department, along with Detectives from the Exploited and Missing Children's Unit/Internet Crimes Against Children Division in Wichita executed a search warrant at two residences in the 600 block of South Verna. Both homes were contacted at the same time and two male subjects were arrested in connection with the case out of Wichita for Distribution of Child Pornography. No force was used to gain entry to the homes and both suspects were transported to the Police Department for questioning. Dustin Runyan, 30-year old white male of Andover was later booked into the Butler County Jail for Sexual Exploitation of a Child. The second male subject brought in to the station was later released with no charges anticipated.

Self-Inflicted Gunshot Wound

On Saturday, November 23rd, at approximately 2:00 a.m. in the morning an officer, patrolling in the 2400 block of North Sandstone, drove up on a man lying in the middle of the road and a female friend standing by him. Upon exiting his vehicle, the officer was told by the hysterical friend that the male had just shot himself. The male subject, a 36 year-old Wichita resident who had a single gunshot wound to the abdomen, was transported to Wesley Medical Center where he underwent emergency surgery and later succumbed to his wound. The investigation revealed that the victim suffered a self-inflicted gunshot wound.

Felony Child Abuse

On Sunday, November 25th, the police department received a report from the mother of a 5-year old boy who had just been picked up from his father's home in Andover and the boy had severe bruising on his buttocks. The boy's mother advised that the father admitted to her that he had spanked the boy, and may have gone a little overboard. The father came in to the Police Department to turn himself in early the next morning (11/26/2019) and was interviewed, then arrested and booked into the Butler County Jail on Felony Child Abuse.



2019 Highlights

Porch Pirate Arrest

On Tuesday, December 3rd officers were flagged down by a citizen in the area of Slate and Fieldstone (Cornerstone Addition) in regards to a suspicious character who may have just stolen a package off the porch of a home. Sgt. Mark Werbin made contact with the suspicious character who was identified as Rick Downey, a 33-year old white male out of Wichita. Through an on-site investigation, and the assistance of at least one Ring Door Bell, it was determined that between 1:30 p.m. and 6:00 p.m. Mr. Downey had stolen packages off the porches of at least four homes in the area. Unable to post bond in Andover, Rick Downey was booked into the Butler County Jail on four counts of Theft.

Developmental Psychology Presentation

On Monday, December 2nd, Tuesday, December 3rd and Thursday, December 5th, Det. Natasha Ward gave presentations to the Butler Community College's "Developmental Psychology" classes. Her presentation was on Juvenile Delinquency and Recidivism and included 3 classes and 35 total students. This is the fourth year in a row that Det. Ward has been invited to present at the college.

Drone With FLIR

On Tuesday, December 17th the Police Department took possession of its first FLIR equipped Drone. The department purchased a DJI Mavic 2 Enterprise Dual Drone with a FLIR MSX Thermal imaging, and attachable speaker, spotlight and beacon, which will be used to search and locate missing individuals such as small children, senior citizens, disabled individuals and/or fleeing suspects.



Burglary in Progress/Police Pursuit

On Thursday, December 19th, at approximately 8:15 a.m. in the morning officers were dispatched to the Cloud Ridge Apartments (217 W. 3rd St.) on the report of a possible burglary in progress and the suspects were in a dark green Chrysler 300. Upon arrival officers observed that the apartment's maintenance worker had the driveway blocked with his truck and was pointing at the suspect vehicle. The suspect vehicle then drove over the grass on to 3rd street and sped off at a high rate of speed. Officers began pursuing the vehicle west bound on 3rd Street, south on Lakeside Drive, then south on 159th where the vehicle lost its front passenger side tire. The vehicle continued south on 159th, across US HWY 54, and then onto Brookhaven where the vehicle lost control on the curve, leaving the road and striking a tree. The driver, who was later identified as Lucas Tullis, a 24-year old male out of Wichita was taken into custody as he tried to escape the vehicle through the sun roof. The passenger, a 27-year old female out of Wichita opened the vehicle door and fell to the ground. Both the driver and passenger were transported to a Wichita Hospital by EMS where the passenger remains. The driver of the vehicle, Lucas Tullis, was released from the hospital and transported back to Andover. During the investigation, the suspect's vehicle was determined to have been stolen out of Bentley, Kansas. Following Lucas Tullis' interview, he was booked into the Butler County Jail on charges of Possession of Stolen Property, Identity Theft, Possession of Methamphetamine, and Possession of Paraphernalia, Criminal Possession of a Weapon and Felony Evade and Elude. Charges are pending on the female passenger.



Christmas Adoption/Caring & Sharing

In November and December, the Police Department raised approximately \$900 through the "Beards for Bucks" fund raising event, and used that money to adopt six (6) families for Christmas in Andover's "Caring & Sharing" program, with officers delivering gifts and dinner to those families on December 18th. Captain Buck Buchanan, Lt. Mike Shinert, Sgt. Troy Snedeker, SRO's Heath Kintzel, Lance Parker and Donnell Hadley all participated in delivering the gifts to the six families. Additionally, on December 24th (Christmas Eve), Captain Buchanan, Lt. Shinert, Sgt. Snedeker and MPO I Joel McLaughlin delivered a Christmas Dinner, including a turkey and a ham, several side dishes as well as deserts, to all of the children and staff at the Children's Home.

Jessica Smith wrote, "Lt. Cundiff has performed his assigned duties with the expertise he has gained over the years as a sworn law enforcement officer and has stepped up to cover manpower shortages to ensure the efficient operations of not only his assigned section but the entire department as well.

This past year, Lt. Cundiff had to give up one Detective position to help cover short staffing in the Patrol Section. During that time, he has worked alongside one of his remaining detectives to ensure continuity of casework and proper coverage of the case load. Lt. Cundiff was aware his remaining detective was working hard to clear a backlog of cases that had built up over time. He chose to assign a majority of the cases to himself to allow her the opportunity to catch up and spend the quality time needed to properly handle the cases. According to Capt. Joe Schroeder, from June 1, 2019 to December 22, 2019, Lt. Cundiff assigned himself 14 felony cases, 13 misdemeanor cases, and one documentation case to follow up on. In addition to handling a large caseload, he has also worked to ensure department goals were met and worked hard to maintain a strong relationship with the Andover Chamber of Commerce despite the workload increase. Lt. Cundiff spent several hours this past year working to ensure officers were properly trained in firearms, taser and other interview skills by conducting classes and overseeing many of the department's qualifications. Lt. Cundiff assisted his lone detective in coordinating crime prevention courses for the Chamber of Commerce as well as provide coverage to allow her to continue with scheduled training courses. Lt. Cundiff takes great pride in this department and works to establish a strong relationship with the patrol section. He has taken time to answer officer's questions about investigations and provided support to them to encourage them to do as much follow-up as possible during their investigations. Other officers in the department feel at ease in speaking to Lt. Cundiff about investigations as well as general law enforcement questions. Lt. Cundiff always makes himself available to all officer's day and night.

Lt. Cundiff is a great example of a dedicated and determined officer who strives to display the department's values of "Compassion, Integrity and Commitment." This sets the bar for other officers to live a life based on our organizational values. It is my belief that he is the most deserving officer in this agency for the 2019 Sworn Officer of the Year.

Therefore, for his actions, efforts and attitude, demonstrated on a daily basis during the past 12 months, as nominated by Jessica Smith, recommended by the Awards Board, and approved by the Chief of Police, Lt. Daimon Cundiff was awarded the 2019 "Officer of the Year Award."

Captain Schroeder wrote, "Ms. Tapia has distinguished herself during this year in not only the performance of her duties but in her dedication to the department and service she provides to support the officers daily. Ms. Tapia has performed her assigned duties with the expertise she has gained over the years as a Communications Officer as well as a level headed supervisor who has had to deal with short staffing issues.

During 2019, Ms. Tapia has worked diligently to prepare the Emergency Communications Section for assessment to become the first CALEA Accredited Communications Center in Kansas. This has required hours upon hours of research, writing policy, developing operating plans and working closely with other staff to ensure the production of "proofs" to satisfy the assessment team and CALEA requirements. When there was an issue with the version of CALEA that was originally assigned being out of date, Ms. Tapia spent her entire weekend working in order to ensure the work was being accomplished. In addition, Ms. Tapia has worked the dispatch console on several occasions in order to make up for short staffing issues. She has spent most of the month on November working 12 hour shifts dispatching in addition to her daily duties of supervision, management of the department's records section, and property and evidence. Not to mention the numerous requests she gets daily from staff and other city department for follow-up and data requests as well as working to hire new dispatchers to fill vacant positions.

Ms. Tapia is a great example of a dedicated and determined employee. In my opinion she is a great choice for Civilian Employee of the Year."

Therefore, for her actions, efforts and attitude, demonstrated on a daily basis during the past 12 months, as nominated by Captain Joe Schroeder, recommended by the Awards Board, and approved by the Chief of Police Emergency Communications Director Becky Tapia was awarded the 2019 "Civilian of the Year Award."



2019 Special Recognition



Life-Saving Award: *"To be conferred upon any member of the department whose actions directly contribute to saving or significantly prolonging some quality of human life. This award will be presented in the form of a ribbon bar and certificate for sworn members, and as a certificate for non-sworn members. All subsequent awards for sworn members will be presented in the form of oak leaf cluster and certificate."*

On November 12th, 2019 Andover Emergency Units were dispatched to 661 Parallel Drive, Andover, KS on a report of a 47-year-old man not breathing and unresponsive. Sgt. Snedeker responded to the call and arrived before EMS. Sgt. Snedeker immediately started doing approximately 200 chest compressions on the patient for approximately four minutes until fire and EMS arrived. Chest compressions and advanced lifesaving measures continued for eight cycles until the patients' heart resumed beating and he started breathing by himself. The patient was transported to the hospital where he remained in a "red" status, but

stable.

Andover Fire Chief Russell stated "From my understanding of the situation, Sgt. Snedeker's actions were very valuable in the potential positive outcome of this patient. When Captain Matson arrived, Sgt. Snedeker was already performing chest compressions. The value of early chest compressions simply cannot be overstated in the return of spontaneous circulation. I have no doubt that Sgt. Snedeker contributed to the return of circulation and increased the patient's chances of survival."

Therefore, having met the requirements of General Order M1218, as recommended by the Awards Board and approved by the Chief of Police, Sgt. Troy R. Snedeker was awarded the department's "Life-Saving Award."



Life-Saving Award: *"To be conferred upon any member of the department whose actions directly contribute to saving or significantly prolonging some quality of human life. This award will be presented in the form of a ribbon bar and certificate for sworn members, and as a certificate for non-sworn members. All subsequent awards for sworn members will be presented in the form of oak leaf cluster and certificate."*

On November 22, 2019 Sergeant Jason J. Arnold responded to 2331 North Grant Road outside the city limits of Andover for a patient who was not breathing and had no pulse. Sgt. Arnold entered the residence and began chest compressions on the patient, who had overdosed on a possibly known substance. Sgt. Arnold continued providing much needed CPR until he was relieved by the Andover Fire and Butler County EMS personnel. EMS personnel were able to administer Narcan to the patient, stopping the overdose.

Lieutenant Kevin Kichler with the Butler County Sheriff's Office stated "Without the timely arrival and actions of Sgt. Arnold, I do not feel the patient would have survived until EMS arrived at the residence. Sgt. Arnold's actions represent the highest values and the law enforcement profession."

Therefore, having met the requirements of General Order M1218, as recommended by the Awards Board and approved by the Chief of Police, Sgt. Jason J. Arnold was awarded the department's "Life-Saving Award."

Citizen Commendation: *"This award may be presented to any person or entity who is not a member of the department but who has materially aided the department or its officers in some way. This includes the assistance in the solution of crime or apprehension of criminals, aiding an officer in the field in a critical situation, and cooperation with or assistance to the department as a whole in any aspect of the department's administration or operations."*

Mia Shields, Paige Volkman and Rheagan Volkman were nominated by Sgt. Mark Werbin for the Citizen Commendation Award. On March 6, 2019, Mia Shields, Paige Volkman and Rheagan Volkman were riding as passengers in a vehicle being driven by their grandmother, Candace Gay Parsons. While travelling east bound on US 54, Ms. Parsons suffered a massive heart attack causing her to lose consciousness while still driving on the roadway causing her to lose control of the vehicle. Mia Shields directed Paige Volkman how to take control of the steering wheel and Paige was able to direct the vehicle out of the oncoming lanes of traffic into a field narrowly missing an electric pole. Rheagan Volkman directed Paige to put the car into neutral causing it to slow and stop safely in the field. Rheagan then called her parents and 911 for help. The actions of these three girls not only saved their grandmother's life but also prevented a motor vehicle accident which could have endangered their lives as well as the lives of other motorists on the roadway. The committee determined that all three of these young ladies materially aided the Andover Police Department and its officers in preventing further tragedy that evening.

Therefore, having met the requirements of General Order M1218, as recommended by the Awards Board and approved by the Chief of Police, Mia Shields, Paige Volkman and Rheagan Volkman were awarded the department's Citizen Commendation.

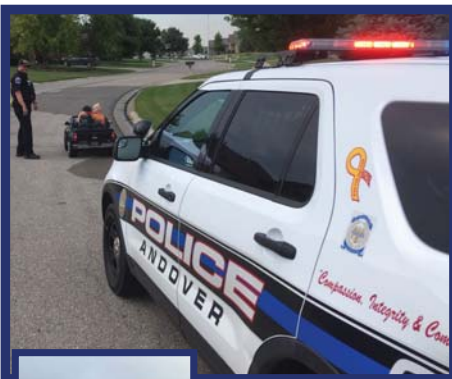
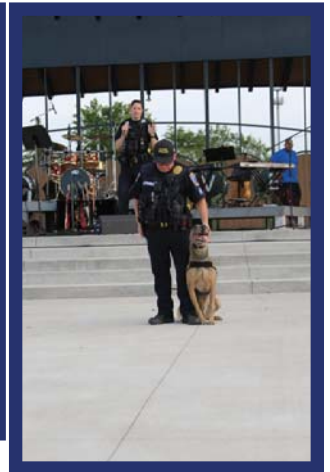

Training Highlights

MANDATORY TRAINING: The police department, in order to provide required training on an annual basis, conducts a mandatory in-service training session, three-times a year (March, June & November). During these training sessions, staff members, including Police and E-911 staff members, receive the necessary training that is recommended on an annual or bi-annual basis in accordance with CALEA standards.



SPRING MANDATORY: On Thursday, March 21st and again on Thursday, March 28th, members of the Police Department, including all sworn and non-sworn members attended the department's mandatory Spring In-Service Training. The training day consisted of 8-hours of training including "Dealing with Mental Illness Procedures," "Breaking Down Barriers: Unconscious Biases," "Domestic Battery Policy Review & Scenarios" and "Crime Scene Investigations: Photography, DNA, Packaging Evidence."

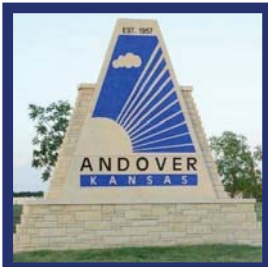
Jurisdiction & Demographics

Seven serious offenses are used to define trends and make comparison across the nation. These offenses are called index crimes or Part I Offenses, and data about them are drawn from the Federal Bureau of Investigation's Uniform Crime Reporting (UCR) program. The offenses consist of four violent crimes (Murder, rape, robbery and aggravated assault) and three property crimes (burglary, larceny-theft and motor vehicle theft).

Within the Part I offenses, Violent crime (Murder, Forcible Rape, Robbery and Agg. Assault) in 2019, with already relatively low numbers in previous years, decreased by a significant 57.9% from the numbers in 2018, and 25% below the numbers in 2017. However, Part I Property Crimes (Burglary, Larceny-Theft, Auto Theft and Arson) actually increased by 2.6%, largely due to a slight increase in larceny/thefts. Due to the significantly low number of Violent crimes, overall Part I offenses decreased by .6%. With the significant decrease in Part I Violent crimes, and a slight decrease in overall Part I offenses, once again the citizens of Andover experienced a very low crime rate in 2019, particularly for a city of over 13,000 residents.

In January the National Council for Home Safety and Security published their 2019 edition of the "Safest Cities in Kansas." Andover was ranked the 5th safest city with a population of at least 10,000 people, immediately behind Leawood, Liberal, Lenexa and Lansing respectively. In a similar study, "Safest Cities in Kansas" for 2019 released in April by "Safewise," an independent review site regarding Home Security, ranked Andover the number 11 safest city in Kansas.

The studies compared Violent Crime and Property Crime, demonstrating that Andover's Violent Crime and Property Crime rates were significantly below the National and Kansas numbers. The national rate for Violent Crime was 4.49 incidents per 1,000 people, and the Kansas rate was 4.75, while Andover experienced 1.37 violent crimes per 1,000 residents. Additionally, the national rate for Property Crimes was 27.11 incidents per 1,000 people, and the Kansas rate was 32.57, while Andover experienced 7.89 property crimes per 1,000 residents.

In 2019, Part II (less serious) offenses decreased by 26% from the numbers of 2018, and only about 15% higher than the numbers of 2017, after decreasing three straight years (2015, 2016 & 2017). Likewise, overall reported crime (Part I & II offenses) decreased by 17.9% due to the significant decreases in Part I Violent Crimes and Part II offenses.

In 2009, the City of Andover was named the 4th safest city in Kansas for driving, based on the previous 5-years of accident data. Since that time, motor vehicle accidents continue to remain relatively low for a city with a population of 13,000, with two major highways passing through its limits (US-54 and I-35). In 2019 the thirty-one Injury Accidents was approximately 6% lower than the thirty-three experienced in 2018 and 2017, and is the 2nd lowest number in over ten-years (lowest in 2016 with 23 injury accidents). Non-Injury accidents decreased slightly in 2019 by .4% below 2018, and 4.2% below 2017 non-injury accidents. Overall, motor vehicle Accidents decreased in 2019 by 1.1% under 2018's motor vehicle accidents, and 4.4% under 2017's motor vehicle accidents.

In 2011 the Andover Police Department received the AAA of Kansas "Silver" Traffic Safety Award for its efforts in Traffic Safety education and enforcement. In 2012 and 2013, due to the addition of a Traffic Safety Committee and the implementation of the Seat Belts Are For Everyone (SAFE) program, the department was awarded the AAA of Kansas "Gold" Award. Over the next 6-years, 2014-2019 due to the department's sustained efforts in traffic safety, the Police Department has been awarded the AAA of Kansas "Platinum" Award, awarded to only a handful of law enforcement agencies statewide. In 2017, overall traffic stops decreased by 2.8% and by another 26.1% in 2018, but increased by 2.7% in 2019. DUI arrests decreased in 2017 by 31.8% for the third straight year in a row, increased in 2018 by 66.7%, then decreased again by 16% in 2019.

Over the past decade Andover's population, the number of businesses and traffic volume has all continued to grow, and as would be expected, so have Calls for Service, Incident Reports, Alarm Calls and Animal Calls over the years. In 2017 "Calls for Service" increased by 13.9%, decreased in 2018 by just under 8.0%, then increased again in 2019 by 8.3%. "Incident Reports" increased in 2017 by 2.2%, decreased in 2018 by 1.9%, and decreased again in 2019 by another 1.1%. "Alarm Calls" increased in 2017 by 11.0%, decreased by 3.6% in 2018, and decreased again in 2019 by 7.4%. "Animal Calls" increased by 3.1% in 2017, decreased by 10.5% in 2018, and remained consistent in 2019.

Use of Force Incidents

The Andover Police Department voluntarily participates in the reporting of major use of force incidents to the National Use of Force Database. Incidents which meet the criteria for reporting are: • When a fatality to a person occurs connected to use of force by a law enforcement officer • When there is serious bodily injury to a person connected to use of force by a law enforcement officer • In the absence of either death or serious bodily injury, when a firearm is discharged by law enforcement at or in the direction of a person. Reporting to the database (Nationally) began in January of 2018. As data becomes available, citizens will be able to use an interactive online data explorer to learn more about use of force incidents. More information can be found at www.fbi.gov. Officers of the Andover Police Department are required to document use of force incidents internally, which are reviewed by the command staff to ensure compliance with applicable laws and departmental rules and regulations. The information from use of force incidents is used to identify areas where additional training or equipment may be of value or procedures which need to be reviewed and/or changed. Internal Use of Force reporting is required for a wider array of incidents not covered by the national data collection and include whenever: a firearm is discharged (including to euthanize an animal); a less-lethal weapon (Taser, pepper spray, baton) is used; weaponless physical force is used to restrain and/or handcuff a subject; any weapon is drawn on an individual and commands given; a Tire Deflation Device is deployed; a K-9 is deployed and engages a person; or any incident where a citizen is injured during the course of an arrest due to resistance.

In 2019, there were a total of 25 applications of force by 12 different officers in 17 separate incidents. Of those 25 applications of force by officers, 11 of those applications involved displaying a weapon while giving verbal commands which resulted in compliance without further escalation. Eight (8) involved empty hand control tactics on subjects who were physical resisting officers. One (1) application was the deployment of a Taser on a subject who had been armed and discharge a round prior to officers' arrival. One (1) application of force was on a Police K-9 that was deployed on a suspect who was fleeing officers during an area search. One (1) application of force was the result of an officer using a baton to pry a suspects hands out from under his body while prone in order to effect an arrest. Finally, there were three (3) applications of force with a firearm to put down a sick or injured animal. department recorded seven (7) Use of Force incidents, none of which met the national criteria. One (1) citizen received visible injury, leading to medical treatment and stitches, and one (1) officer received a minor visible injury.

Only one incident which involved a Police K-9 bite resulted in injury to the suspect who was given first aid by EMS on the scene and released for transport to jail. No officers were injured during a use of force incident in 2019.

DEPARTMENT COMPLAINTS/POLICE VEHICLE ACCIDENTS

In order to maintain a high level of integrity and trust from the citizens it serves, a Police Department must be willing and open to the acceptance of all complaints, including anonymous complaints, and provide a formal and transparent system for the processing of these complaints relative to Department operations, policies and procedures, and the conduct of its personnel. The character and the reputation of the Department rest on an adequate program of fair and impartial investigations.

A complaint is defined as an act of expressed dissatisfaction, which relates to the Andover Police Department's operations, policies and procedures, or conduct of department personnel. The conclusions of all complaints are categorized into one of five findings, "Unfounded," "Exonerated," "Not Sustained," "Sustained" and "Sustained Against Policy." The Andover Police Department has always enjoyed a relatively low number of citizen complaints over the years, usually averaging around 6 to 8 per year prior to accreditation in 2013. However, since accreditation in early 2013, the Police Department has average approximately 1.6 citizen complaints per year (2013-2019), with only two citizen complaints received in the previous two years (2018-2019), and a total of five complaints received in the previous 3-years (2017-2019). This is just one example of the commitment, professionalism, dedication and character possessed by each member of the department's staff, and a demonstration of public service that is almost unheard of. This number is made even more remarkable considering that the officers, during this same 3-year time period, responded to 64,004 calls for service, made 9,725 vehicle stops, issued 5,386 citations, took 5,118 reports and made 943 arrests.

Unfounded: The investigation conclusively proved that the act complained of did not occur. This finding also applies when an individual employee named in the complaint was not involved in the act, which may have occurred.

Exonerated: The act which provided the basis for the complaint or allegation occurred; however, the investigation revealed that the act was justified, lawful and proper.

Not Sustained: The investigation failed to disclose sufficient evidence to clearly prove the allegation made in the complaint or to conclusively disprove such allegation.

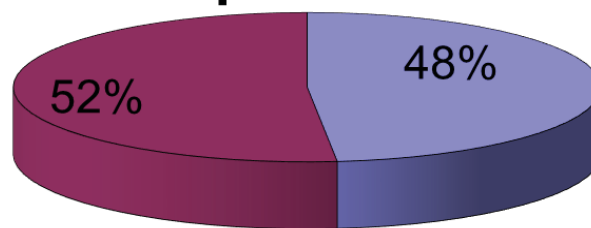


The Andover Police Department is committed to providing high quality customer service to its citizens. In addition to tracking and documenting citizen complaints, the Police Department also surveys the community on a regular basis, to determine our citizen's attitudes and opinions with respect to: overall agency performance; overall competence of agency employees; citizens' perception of officers' attitudes and behavior; community concern over safety and security within the agency's service area; and citizens' recommendations and suggestions for improvements.

Three days a month, Citizen Satisfaction Surveys are mailed out to individuals that have had contact with the police department, either by being involved in a motor vehicle accident, making a police report, or receiving a traffic citation/warning. Additionally, each calendar month, department supervisors conduct a minimum of one citizen follow-up for each officer assigned to their team, and that follow-up will include the completion of a Citizen Satisfaction Survey. Finally, the on-line availability for citizens to complete the Citizen Satisfaction Survey www.andoverks.com/pdsurvey is advertised on the back of every department issued business card.

In 2019, seventy-six (76) Citizen Satisfaction surveys were completed and returned by citizens, making a total of 558 surveys completed since February of 2012. To date, the surveys indicate that 48.4%, slightly less than half of the respondents, had had prior contact with members of the Andover Police Department.

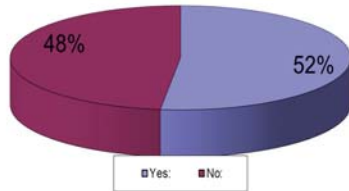
E-911 Communications

In 2019 citizens were asked "In regards to the most recent incident, did they contact the Police Department utilizing the services of our E-911 Center?" If so, please rate our E-911 services in following areas: "Professionalism, Customer Service, Timeliness and overall Quality of E-911 Service." From 2012 through 2019, 51.9% of the respondents that completed the survey indicated that their initial contact with the Police Department has been through the E-911 Communications Center. Additionally, during this same time-period, the respondents rated the dispatchers Good or Excellent 99.3% of the time on "Professionalism," 99.3% of the time for on "Customer Service" and 98.0% of the time on "Timeliness."

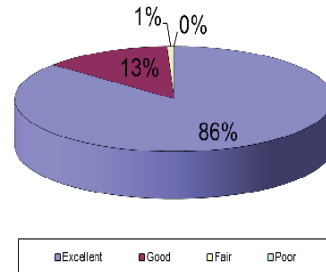

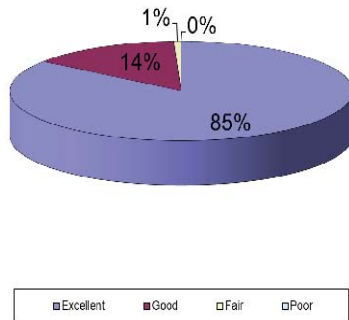
Contact Police Department through E-911



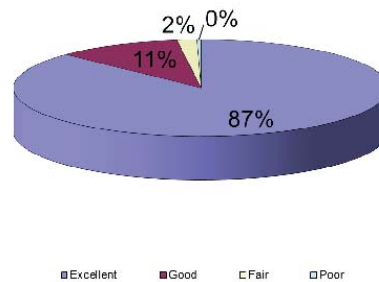
Dispatcher's Professionalism

Dispatcher's Timeliness



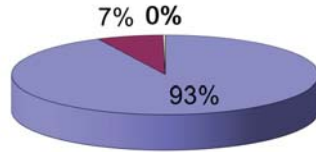

From 2012 through December 31, 2019, the respondents rated the officers Good or Excellent 99.8% of the time on the Officer's Appearance; 98.6% of the time on the Officer's Professional Conduct; 97.1% of the time on the Officer's Concern (Compassion); 97.3% of the time on the Officer's Ability to Put You at Ease; 98.2% of the time on the Officer's Knowledge; 98.6% of the time on the Officer's "Fairness" (Integrity); 97.8% of the time on the Officer's Helpfulness (Commitment); and 97.6% of the time on the Officer's Response time.

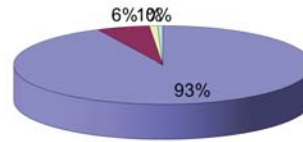


Officer's Appearance



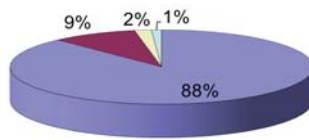

Officer's Professional Conduct



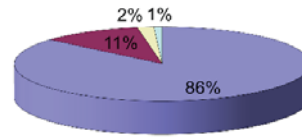

Officer's Concern (Compassion)



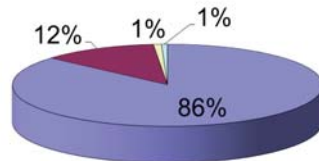

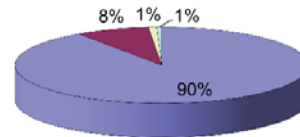

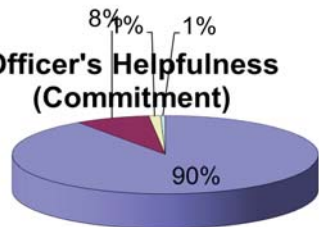

Officer's Fairness (Integrity)



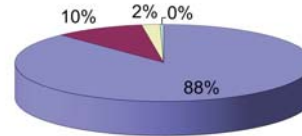

Officer's Response Time



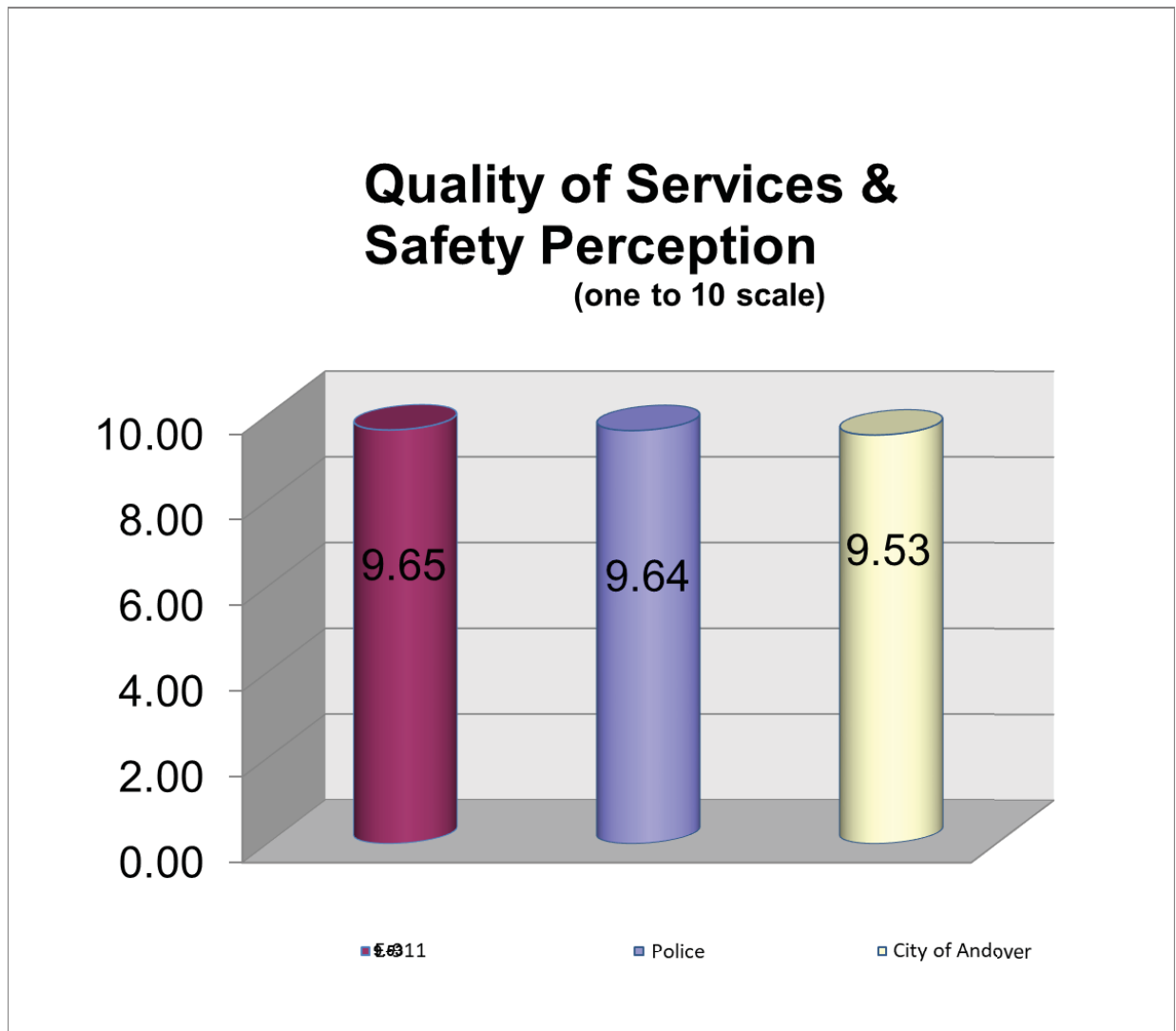

Overall Survey Results

On the Citizen Satisfaction Survey, citizens are asked, on a one to ten scale, to rate their overall satisfaction with the E-911 Communications Center, the Andover Police Department, and how safe they feel living in the Andover community. From 2012 through December 31, 2019, the citizens have reported an average 9.65 satisfaction rate for Andover's E-911 Communications Center, an average 9.64 satisfaction rate for the Police Department, and reported a 9.53 average rating for feeling safe in Andover.

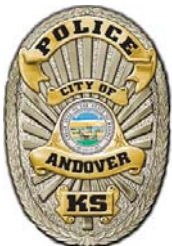


In the Citizen Satisfaction Survey, respondents are also asked to provide written recommendations and suggestions for department and officer improvements. Twenty-nine (29) of the seventy-six (76), approximately 38.2% of the surveys returned in 2019, included comments and/or constructive feedback and suggestions.
